HB 3070 - An act amending the Kansas general corporation code.

John Wine, Legal Counsel for the Secretary of State appeared before the committee in support of this bill. He stated that sections 1, 2 and 3 adopt provisions conforming Kansas' corporation code to Delaware's code and section 4 corrects a previous error.

Rep. Duncan moved to at HB 3070 be reported favorably. Seconded by Rep. Wunsch. Motion carried on a voice vote.

HB 2735 - An act concerning law enforcement officers; relating to psychological testing thereof.

Rep. Sandy Duncan explained the provisions of this bill to the committee stating that the regulations of the law enforcement officers' academy had long contained a regulation requiring psychological evaluation of law enforcement officers and that it had been eliminated by the commissioners. This bill would reinstitute that requirement. He stated that with passage of this bill the officers would be tested twice; once upon hiring by the local agency and again during their training at the academy. The testing at the academy would not be changed by passage of this bill but the first testing would be. He stated that the Kansas Highway Patrol supports this bill and feels that a person who is psychologically unfit to be a law enforcement officer would reflect badly on the profession if allowed to pursue that career. Rep. Cloud moved to report HB 2735 favorable for passage. Seconded by Rep. Walker. Rep. Bideau made a substitute motion to delete the term "successfully" in both places where it appears. Seconded by Rep. Douville. Motion carried on a voice vote. Rep. Bideau made a substitute motion to delete section 2. Seconded by Rep. Vancrum. Motion failed 7 votes to 9. Rep. Cloud's motion carried on a voice vote.

HB 2672 - An act concerning hospitals; relating to liens upon personal injury damages recovered by patients.

Rep. Buehler moved to table HB 2672. Seconded by Rep. Cloud. Motion carried on a voice vote.

HB 2686 - An act relating to the payment of attorney fees.

Rep. Walker moved to report HB 2686 adversely. Seconded by Rep. Roy. Motion carried on a <u>voice vote.</u>

HB 2752 - An act concerning the operation or attempted operation of a motor vehicle; relating to certain tests fro blood alcohol concentration.

Mary Torrence presented a balloon incorporating amendments dealing with the objections the Department of Revenue had to this bill as originally drafted. They separate the provisions of this bill from the implied consent laws. Rep. Buehler moved to adopt the provisions of the balloon. Seconded by Rep. Walker. Motion carried on a voice vote. Rep. Buehler moved to report HB 2752 as amended favorable for passage. Seconded by Rep.

Snowbarger.

- HB 2907 An act concerning crimes and punishments; relating to sentencing and the ordering of restitution.
- Rep. Solbach moved to table HB 2907. Seconded by Rep. Walker. Motion carried on a voice vote.
- HB 2927 An act concerning crimes; relating to disposition of certain moneys received as a result of the commission of a crime.
- Rep. Buehler moved to report HB 2927 favorable for passage. Seconded by Rep. Wunsch. There was discussion that HB 2986 deals with similar subject matter and would have the same result with no problem of a constitutionality challenge. Motion carried 8 votes to 7.
- HB 2962 An act concerning domestic relations; relating to child custody orders in certain actions.
- Rep. Whiteman moved to report HB 2962 favorable for passage. Seconded by Rep. Solbach. Motion carried on a voice vote.
- HB 3057 An act concerning children; relating to certain traffic offenses.
- Mary Torrence presented a balloon containing amendments requested by the Division of Vehicles. Rep. Vancrum moved to adopt the amendments contained in the balloon. Seconded by Rep. Snowbarger. Motion carried on a voice vote. Rep. Vancrum moved to report HB 3057 as amended favorable for passage. Seconded by Rep. Wagnon. Motion carried on a voice vote.
- HB 3058 An act concerning traffic citations.
- Rep. Walker moved to incorporate the amendments presented in a balloon presented at last week's meeting along with the amendments presented by Col. Cantwell during his testimony on this bill. Seconded by Rep. Douville. Motion carried on a voice vote. Rep. Walker moved to report HB 3058 as amended favorable for passage. Seconded by Rep. Douville. Motion carried on a voice vote.
- HB 2991 An act concerning the Kansas healing arts act; relating to unprofessional conduct of licensees.
- Rep. Solbach moved to amend section 12 of the balloon to read "providing or prescribing clearly unnecessary drugs, treatment or services". Seconded by Rep. Wagnon. Rep. Snowbarger made a substitute motion to adopt the entire balloon as proposed. Seconded by Rep. Vancrum. Rep. Roy moved to divide the balloon. The deletion of section 2 failed on a voice vote. The amendment at line 61 carried on a voice vote. Rep. Solbach made a motion to insert "not" after "apply" in line 108. Seconded by Rep. Roy. Motion carried on a voice vote. Rep. Snowbarger moved to table HB 2991. Seconded by Rep. Douville. Motion carried 10 votes to 5.
- HB 2924 An act concerning crimes, punishments and criminal procedure; relating to restitution.
- Rep. O'Neal moved to strike section 5. Seconded by Rep. Vancrum. Motion carried on a voice vote. Rep. O'Neal moved to adopt the amendments in the balloon presented. Seconded
