Chairman Ivan Sand called the meeting to order, welcomed the Committee, and made introductory remarks as follow:

- that the committee books had been placed in accordance with the 1985 seating arrangement, but that committee members should feel free to rearrange their seats.
- that cooperation is requested among committee members regarding smoking at committee meetings.
- that the Kansas Association of Counties and the League of Kansas Municipalities will host a dinner for the committee, scheduled for February 17, 1986.
- that the Committee should be aware of 1986 deadlines for introduction and consideration of bills.

Mr. Glenn Cogswell, representing the North Topeka Drainage District, appeared to request a new committee bill which would correct an error included in 1985 HB 2483. The new bill would change a reference of K.S.A 24-458 to K.S.A. 24-401, et seq. (See Attachment I.)

Rep. Phil Klein made a motion that the requested change be included in a new committee bill. Rep. Samuel Sifers seconded the motion. The motion carried.

Chairman Ivan Sand reviewed held-over and re-referred bills and called for action on HB 2478.

Rep. Phil Klein explained that the groups that had proposed the bill now wish the bill to be killed. Rep. Klein made a motion that the bill be reported unfavorably. Rep. Carl Holmes seconded the motion. The motion carried.

Chairman Sand called for introductions of Committee guests. Self introductions were made by Rebecca Crenshaw, Kansas Cemetery Association; Kim Dewey, Sedgwick County; Willie Martin, Sedgwick County; and Gerry Ray, Johnson County.

Chairman Sand referred to and gave background from the 1985 summer interim study of the annexation issue, proposal No. 45.

Mr. Mike Heim, Staff, reviewed 1985 interim committee proposals No. 33 and No. 46. Mr. Heim pointed out that HB 2656 resulted from proposal No. 33; that the Special Committee on Federal and State Affairs urged regional planning commissions to be involved in economic development. Mr. Heim said that HB 2659 and HB 2660 were results from proposal No. 46; that the Special Committee on Local Government had reinserted "mentally ill" into the provisions of the 1985 HB 2775; that as a result of hearings on 1985 SB 369, handicapped accessibility of apartment units and hotel and motel facilities was considered and that the 10% requirement was changed to provisions set out in HB 2660. Meeting adjourned.

HOUSE BILL NO. By Committee on Local Government

AN ACT relating to drainage districts; concerning notice of hearing on petition for enlargement of district; amending K.S.A. 1985 Supp. 24-465 and repealing the existing section.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF KANSAS:

Section 1. K.S.A. 1985 Supp. 24-465 is hereby amended to read as follows: 24-465. Whenever a petition in conformity to the next preceding section, signed by not less than two-fifths of the total number of taxpayers, residing within both the original district and the territory named in the petition or by all of the directors of any drainage district incorporated pursuant to K.S.A. 24-450 24-401, et seq. shall be presented to the board of county commissioners of the county designated in the preceding section praying that the limits of the drainage district be extended to include within it boundaries the territory described in the petition it shall be the duty forthwith of such board of county commissioners to fix a time for the hearing of such petition and to cause the county clerk to give notice thereof by one publication in some newspaper, published and of general circulation in the county, at least ten days before the day fixed for the hearing: PROVIDED, That if such petition be signed by any number in excess of two-fifths of the total number of taxpayers residing within the territory over which the extension is to be made, it shall not be necessary to furnish a petition signed by the taxpayers residing within the original drainage district.

- Sec. 2. K.S.A. 1985 Supp. 24-465 is hereby repealed.
- Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
