With the consent of his second, Representative Shore changed his motion to conceptually amend the bill to provide that the transportation to and use of natural gas for the purpose of irrigation which requires crossing leased boundaries shall not be prohibited provided permission has been granted from either the royalty owner or producer and proper pipeline easements are obtained. The transportation to and use of natural gas for the purpose of irrigation or grain drying under the provision of this section shall be used exclusively on a farm. Also, making the effective date the Kansas Register. The motion was seconded by Representative Knopp. Motion passed.

A motion was made by Representative Shore to recommend HB-3142 as amended favorable for passage. The motion was seconded by Representative Knopp. Motion passed 10-4 on a division.
