Senator Allen called the Committee to order and called for action on Committee minutes.

Senator Karr made a motion the minutes of the two Committee meetings on March 7 be approved. Senator Gordon seconded the motion. Motion carried.

The Chairman announced that March 20 had been designated as "Agriculture Day" and he called attention to a resolution (attachment 1) written declaring that March 20 be proclaimed as "Agriculture Day".

Senator Kerr moved the Committee recommend the resolution for adoption. Senator Karr seconded the motion. Motion carried.

The Chairman then called the Committees' attention to SB 735 and ask Senator Gannon to explain the bill.

Senator Gannon stated SB 735 is known as the Kansas displaced farmer act. He explained that SB 735 provides grants for schooling for displaced farmers for vocational or technical schooling for a period of not over 12 months also includes the provision for the student to receive \$200 monthly for subsistence expenses. Senator Gannon stated applicants for this program must have a job lined up to commence when the schooling is completed. This program would be available for 500 applicants within our state. He stated the fiscal note was figured to be \$1.5 million.

The Chairman thanked Senator Gannon and called on Bill Fuller to testify.

Mr. Fuller expressed support for legislation that would help retrain displaced farmers. He stated since the average age of a displaced farmer is 46 years of age that maybe vocational training would be more helpful than grants to attend a college or university. Mr. Fuller stated a grant program could be a good tool to help our displaced farmers. Mr. Fuller expressed support for both SB 735 and SB 591 as both address a real need of our displaced farmers. He encouraged the Committee to work for combining proposed legislation so that legislation is passed that will offer help to displaced farmers in Kansas.

During Committee discussion the concern was expressed that maybe funds should be spent in trying to help keep small farmers on their farms rather than spending the funds on schooling. Also the question was posed regarding the availability of jobs after completing schooling. The concern was expressed that the state should not retrain a farmer and then have him accept a job outside our state. It was suggested that this program could be worked like in medical school; that is, if a job is accepted outside the state, the student repays the state for the cost of the education.

The Chairman thanked Mr. Fuller and called on Becky Crenshaw to testify.

Ms. Crenshaw expressed support for SB 735 because it provides for free schooling at vocational-technical schools. She stated a person at the average age of displaced farmers in Kansas today is more apt to choose going to a vocational school for a period of up to 12 months rather than a 4 year college. She also stated this type of schooling may appeal to farm wives also.

The Chairman thanked Ms. Crenshaw and declared the hearing closed on SB 735. The Chairman then announced he was appointing a subcommittee to work on legislation to combine SB 591 and SB 735. He appointed Senator Doyen, chairman, Senator Gannon and Senator Gordon. The Chairman announced the Committee would be meeting on March 21 to hear the report on this subcommittee and for possible action on bills previously heard. The Chairman adjourned the Committee at 10:45 a.m.
