Senate Bill 540 - Professional malpractice by licensees of state other than health care providers.

Senate Bill 572 - Uniform rights of the terminally ill act.

Senator Hoferer seconded the motion. Senator Talkington made a conceptual motion to amend the bill to provide, the determination of the status of the patient to justify implementing this procedure would be two doctors instead of one. Sen Winter seconded the motion. The motion carried. Senator Talkington moved to report the bill favorably as amended. Senator Winter seconded the motion, and the motion carried.
