Representative Campbell, Chairman of the House Agriculture and Small Business Committee, called the joint meeting of the Senate Agriculture Committee and the House Agriculture and Small Business Committee to order. The Chairman welcomed Representative Roberts and Representative Glickman to the Committee. The Chairman then introduced the Congressmen to the Committees.

The Congressmen discussed their agricultural related committee assignments and explained possible changes that Congress may make with the present farm program. They explained that the present farm program is working well for some farmers. The Congressmen stated that all legislation must be budget responsible and that the greatest need is for predictable and consistent programs so that farmers know what they can plan on. They stated the greatest need is for higher prices for farm products and to be competitive in the world market. They also stated they felt money would be put into the Federal Credit System so that it will be able to continue. The Congressmen expressed appreciation for past suggestions and support from the Kansas Legislature and encouraged constant input from the agriculture committees.

Chairman Campbell thanked Congressmen Roberts and Glickman for their presentations and then adjourned the Committees at 9:57.
