Chairperson Harper called the meeting to order and recognized Nancy Ryan. Ms. Ryan came before the committee to give them a briefing on SB 159. This is a bill which relates to mailing of ballots. This bill provides that on the return identification envelope the language shall read in compliance with Kansas law instead of Chapter 25 of Kansas Statutes Annotated, and thus is a technical cleanup bill recommended by her office.

As there were no questions, the hearing closed on SB 159.

Representative Blumenthal made a motion that SB 159 be passed favorably and that it be placed on the Consent Calendar. Seconded by Representative Flottman. Motion carried.

SB 106 was next on the agenda for hearing today. This is a bill which relates to the qualifications of certain city officers. The Chair recognized Ron Thornburgh, Secretary of State's office. Mr. Thornburgh came before the committee telling them that this bill is a cleanup bill and asked that Jim Kaup, League of Kansas Municipalities, give the committee a briefing on the intent of this bill. Mr. Kaup told the committee his office had recommended this piece of legislation as it is their thinking that there is a lack of precision in the wording of the statutes which establish residency qualifications of council members, commissioners, and mayors, as to when residency must be establised in order for a candidate to be legally qualified to hold elective city office. Therefore, this bill does provide that to be legally qualified to hold elective city office, the person must be a qualified elector as of the date of filing for office.

Following a discussion period. the hearing closed on SB 106.

SB 160, is an act relating to irregularities in the notice and conduct of elections, and this was next on the agenda. The Chair recognized Norene Staab, Shawnee County Elections office. Ms. Staab came before the committee to give them a briefing of why this legislation had been requested. This bill is relating to question submitted elections and extends the provisions of KSA 25-702(a) regarding safeguards of elections to question submitted elections including both bond elections and local referendum.

Following a discussion period, the hearing closed on SB 160.

Representative Baker made a motion to favorably pass SB 160 from committee, and that it be placed on the Consent Calendar. Seconded by Representative Blumenthal. Motion carried.
