The minutes of March 4 were approved.

The hearing on $\underline{SB\ 322}$ and $\underline{SB\ 323}$, both relating to the committee on surety bonds and insurance, began with staff reviewing the amendments. It was explained that the bills do nothing other than make technical amendments. 75-4109 and 75-4101 wer amended last year by two separate bills. The normal procedure would be to run a new bill which dovetailed them into the same section, but this was not done. These bills bring these two amendments into the same section. The only change in $\underline{SB\ 322}$ is in lines 29 and 30 which deals with aircraft insurance for KTI. Mr. Todd of the Insurance Department had informed the Revisor that another amendment is needed on line 30 where 76-748 needs to be changed to 76-394 as this section has been recodified. As to $\underline{SB\ 323}$, the change occurs on line 38 which references 76-749. The stricken type on line 41 is getting rid of an old effective provision that no longer needs to be there. Staff condluded that the effect of the two bills is that it merges two statutes into a new clean statute.

Ron Todd, Kansas Insurance Department, testified briefly regarding the insurance involved in these two bills. Short committee discussion regarding the insurance followed.

Sen. Kerr made a motion to amend SB 322 on lines 29 and 30 as suggested, Sen. Warren seconded, and the motion carried.

Sen. Gannon made a motion to recommend SB 322 favorable for passage as amended, Sen. Warren seconded, and the motion carried.

Sen. Werts made a motion to recommend SB 323 favorable for passage and to put it on the Consent Calendar, Sen. Karr seconded, and the motion carried.

Attention was turned to <u>SB 232</u> regarding property insurance adjusters, which had been previously heard. Sen. Gannon asked Mr. Todd his opinion in regard to testimony stating that there is widespread collusion among contractors. Mr. Todd answered that the Insurance Department has had reports of some problems with this, but it is difficult to prove bid fixing. Sen. Mulich has said that it is more widespread than the Insurance Department has been able to discover. With reference to the suggested amendment by Sen. Mulich for a requirement of three estimates, Mr. Todd said that anytime you require anything as a general rule, it does run up administrative costs. The chairman clarified the amendments offered for Mr. Todd. Sen. Gannon said he could not see how administration of estimates would increase costs. The chairman said it takes more time for the adjuster to compare them. Mr. Todd said that the \$5,000 amendment would do away with a lot of the estimates because many are for lower amounts than this such as in the case of hail claims.

Sen. Strick made a motion to adopt the amendments offered by Sen. Mulich, Sen. Warren seconded, and the motion carried.
