Chairman Thiessen called the meeting to order at 1:30 p.m.

Senator Ehrlich moved to approve the minutes of March 02, 1987, and the minutes of March 03, 1987, seconded by Senator Morris. The motion carried.

Chairman Thiessen turned attention to SB248, and asked the committee members if there were any questions regarding the bill, or if they were ready for action on the bill.

SB248-An Act concerning employment; relating to private job listing services; providing for the licensure thereof; amending K.S.A 44-401 and repealing the existing section.

Senator Ehrlich said there was a question as to whether or not we should establish a rate for the license, on page 3, line 0089, new section 3 of the bill.

Senator Morris made a conceptual motion to put a rate, not to exceed \$100.00 for the license, seconded by Senator Feleciano. The conceptual motion carried.

Chairman Thiessen asked if there was any other discussion on the bill.

Senator Daniels said she thought someplace there should be, the list could not be sold for a maximum of dollars, but she did not know how much or where to put it in the bill.

<u>Senator Morris</u> said he thought that would be out of place, as it seems the market place would set a value on that. If there are a lot of people out of work, and a lot of jobs, maybe it could be higher and if they can't give it away, maybe it would be low.

Senator Thiessen said it could change, and currently they said they were charging \$75.00.

Senator Feleciano asked Jerry Donaldson, how often they have to update their list, and can you go in and purchase a list that is 3 weeks old, and all the jobs are taken already? If we are going to leave this wide open, and let the firm charge whatever they please. What does it say about you getting your money back in the bill. Can you spell it out in the bill?

<u>Jerry Donaldson</u> said Section 6 of the bill, does have a provision. A private job listing service shall not publish or cause to be published any information which it knows or reasonably should know is false or deceptive. That may cover the issue of how long the jobs are available.

<u>Senator Morris</u> said those people are already protected under the Kansas Consumer Protection Act, and if there is fraud or misrepresentation, they have every right to recover. It is the same as anybody else selling any other product.

Senator Thiessen said they will operate under the supervision of the State Department of Human Resources, and any violation of the act, is a Class C misdemeanor.

Senator Werts made a motion for a technical amendment, to change the word "not" to "no" at the end of line, 0109, seconded by Senator Ehrlich. The motion carried.
