TESTIMONY BEFORE SENATE LABOR AND INDUSTRY COMMITTEE

Workers Compensation, H.B. 2186 March 24, 1987

Thank you, Mr. Chairman, for this opportunity to share with your committee our support for H.B. 2186, a comprehensive reform of the Kansas workers compensation law.

The Workman's Compensation Insurance program is not working as it was originally intended. Recent judicial interpretations and administrative applications of the Act have departed from the original legislative intent and increased costs to employers.

As originally devised, a workers compensation plan was an alternative to full-blown tort litigation of claims. Both parties gave up some of their legal rights to participate in a program that compensates all work related injuries at an affordable level and in a reasonable and predictable manner.

Over the years, our workers compensation program has evolved into a system that discourages the injured employee from trying to return to work as soon as possible and discourages the employer from providing the employee any assistance in learning new skills when disabled. Only lawyers have found a way to make the workers compensation laws work to their benefit.

H.B. 2186 addresses many of the problems that have developed. The bill clarifies the law in several areas including: providing balance to judicial interpretation of the Act, reversal of the Antwi decision impacting vocational rehabilitation, definition of permanent partial general disability, and exclusion of employer paid taxes in calculating compensation benefits.

The bill is not without balance. Maximum benefit levels are increased in several areas. Employers that refuse to pay benefits on schedule are subjected to tougher penalties. And vocational rehabilitation incentives will help return many disabled employees to meaningful employment.

Boeing strongly endorses taking positive action on workers compensation reform this year. Your support of H.B. 2186 would be greatly appreciated.
