SB 142 - FY 1988 Appropriations for Department of Transportation and Highway Patro1

Senator Doyen reviewed the Senate Subcommittee Report on SB 244, Supplemental Appropriations Bill, and SB 142. Staff explained that the House Appropriations Committee passed HB 2198 as amended which is legislation necessary for enactment of the Governor's recommendations regarding transfer of sales tax receipts to the State Highway Fund.

Senator Johnston made a conceptual motion to amend the Subcommittee Report regarding the Department of Transportation by adding a statement indicating that even though the Subcommittee Report is prepared on the Governor's recommendation in respect to the transfer of sales tax receipts from the State General Fund to the State Highway Fund that the adoption of the report does not mean agreement with the policy and that the issue will be debated when the Committee receives HB 2198. Senator Doyen seconded the motion. The motion carried on a voice vote with Senator Feleciano voting no.

Senator Doyen moved and Senator Talkington seconded a motion to report SB 142 favorably for passage as amended. The motion carried on a roll call vote.

Senator Talkington made a motion, and Senator Gaines seconded, for the approval of the introduction of two bills. One authorizes and directs the state Historical Society to transfer ownership and operations of six historic sites to a local governmental entity or appropriate historic or other public or private corporation, society, association or individual, and the other allows transfer of all monies in the duplicate book fund and computerized library services fund to the state library fund and abolish these two funds. The motion carried by voice vote.

Senator Winter moved, Senator Gaines seconded, to approve introduction of a bill concerning the Kansas community mental health centers assistance act. The motion carried on a voice vote.

Senator Feleciano moved, Senator Doyen seconded, approval for Senator Doyen to introduce legislation which would establish a program for equalization of state aid for county extension services. The motion carried by voice vote.

The Chairman pointed out new language contained in SB 142, as well as other bills, dealing with federal funds, page five, line 260. He directed staff to issue a memorandum containing detailed information concerning this language.

Senator Werts moved, Senator Winter seconded, the approval of the minutes from the February 17, 1987 meeting. The motion carried by voice vote.

The Chairman adjourned the meeting at 12:15 p.m.
