Final Action on HB 3024 - abolishing boards, committees, commissions

Discussion began. The Chairman reminded the committee that items (g), (p) and (r) had been deleted from the bill.

Representative Barr moved item (d) land survey advisory committee created by K.S.A. 58-2007 be deleted from the bill.**Representative Schauf gave a second to the amendment. Motion carried

Discussion took place on the sculpture for the top of the state capitol. Several members expressed comments to the effect that the panel should have more time to meet for discussion and selection.

Representative Sprague moved to amend HB 3024, item (L) by adding 'July 1, 1989'. Representative Brown gave a second to the motion. The motion carried.

Discussion began on item (b) agricultural labor relations board created by K.S.A. 44-820. Several comments for and against keeping the board were made.

Representative Sughrue moved to delete (b) agricultural labor relations board from HB 3024. Representative Bowden gave a second to the motion. The motion failed.

Discussion began on item (n) information systems policy board created by K.S.A. 75-4708. One of the committee members commented that Howard Schwartz, Judicial Administrator, said this was an integral part of the system and told how it links with the executive branch of government. SRS Child Support Enforcement is just coming on the system and this is a crucial area also.

Representative Sebelius moved to delete (n) information systems policy board from HB 3024. Representative Bowden gave a second to the motion. The motion carried.

Another amendment was distributed by staff which creates the natural and scientific areas advisory board, with the secretary of wildlife and parks as a board member.

Representative Bowden moved the amendment be adopted. Representative Graeber seconded the motion. The motion carried.

Representative Ramirez moved HB 3024 be passed favorably as amended. Representative Weimer gave a second to the motion. The motion carried.

The Committee turned to HB 3009 - mined land conservation and reclamation board

A balloon was distributed which showed the amendment on page 9, line 315 and line 316 'department who performs any function or duty under this act'. Wording in the rest of the bill was changed to reflect proper compliance.

Representative Schauf moved to adopt the amendment. Representative Ramirez seconded The motion carried. the motion.

Representative Brown moved to pass HB 3009 out favorably as amended. Representative Graeber gave a second to the motion. The motion carried.
