TESTIMONY IN SUPPORT OF BILL # 2945

Presented by: Dr. Howard P. Killough of Winfield, Kansas; Legislative Chairman for the Department of Kansas of the National Pearl Harbor Survivors Association and appointed by the Kansas State Chairman, Donald S. Spitzengel of Kansas City, Kansas.

Chairman Walker and members of the Government Organizational Committee. I appreciate the opportunity to be present with this committee to plea for the passage of House Bill #2945 sponsored by Representative Flottman and eighty other of your colleagues.

On December 7, 1941, I reported for duty at the Schofield Barracks Hospital and for the first two hours I was Triage officer, having the duty to examine casualties to determine which one would go to surgery next. After that I was called into surgery where I spent the rest of Sunday, Sunday night and into Monday morning. All of the aircraft on the Island of Oahu and practically everything afloat in Pearl Harbor was either totally destroyed or extensively damaged. The cost of materials was great, but the cost in human life and the suffering of those maimed for the remainder of their lives and those scared inwardly that time will not erase—there is no price that can be placed upon those casualties.

I have only mentioned those things to help us realize the importance of House Bill #2945 as an annual reminder to all Kansans through all time of the sacrifices that have been made that they might continue to have the freedom that we enjoy today.

This committee has within its power today to say "Yes, we in Kansas will Remember Pearl Harbor and Keep America Strong". I also feel that in your window you will make that decision.

Again, thank you, Chairman Walker and all you Committee members for allowing us this opportunity to meet with you today, and a special thanks to Representative Flottman and the eighty Co-sponsors for their hours of preparation of this bill.



JUSPUT ...A Letter From The Editor

We must not allow the youth of America to grow up in ignorance nor the older generation to forget...



Colonel Dennis Devine of Little Rock, Arkansas recently sent Headquarters a clipping from the Sunday, December 6, 1981 Issue of the ARKANSAS DEMOCRAT. The headline read, "Pearl Harbor Query Stumps 1 in 6."

According to the article, a nationwide scientific sampling of 1,602 adults were telephoned in a poll conducted by the Associated Press and NBC News. They were asked the question, "Do you know why Pearl Harbor is important in American History?"

Sixteen percent either said no, said they were not sure, or incorrectly identified Pearl Harbor. According to the poll, less than two-thirds of the respondents who had not graduated from High School knew the significance of Pearl Harbor. More importantly, only seven out of ten in the eighteen to twenty-four age bracket knew why Pearl Harbor should be remembered. As shocking as it may seem, the poll revealed that one out of every six adult Americans cannot correctly identify that day President Roosevelt said would live in infamy.

In our travels around the country with CAF aircraft, and in talking with young people, we have seen evidence that some of the schools in this country are not adequately teaching their students the significance of certain portions of American history. We have suspected that some of our educators have neglected to teach their students of the accomplishments and sacrifices made by soldier and civilian alike during WWII. This period in our history, 1939 to 1945, should have taught us and the rest of the free world some important lessons.

We of the CAF have an opportunity to do something worthwhile for our country. As custodians of these airplanes, perhaps we should consider it an obligation. We must not allow the youth of America to grow up in Ignorance nor the older generations to forget this, the most important part of our history since 1776.

TERRITORY OF HAWAII A PROCLAMATION

WHEREAS, it is provided by Section 67 of the Organic Act of the Territory of Hawaii, approved April 30, 1900, that, whenever it becomes necessary, the Governor of that territory may call upon the commander of the military forces of the United States in that territory to prevent invasion; and

WHEREAS, it is further provided by the said section that the governor may in case of invasion or imminent danger thereof, when the public safety requires it, suspend the privilege of the writ of habeas corpus and place the territory under martial law; and

WHEREAS, the armed forces of the Empire of Japan have this day attacked and invaded the shores of the Hawaiian Islands; and

WHEREAS, it has become necessary to repel such attack and invasion; and WHEREAS, the public safety requires;

NOW, THEREFORE, I, J. B. POINDEXTER, Governor of the Territory of Hawaii, do hereby announce that, pursuant to said section, I have called upon the Commanding General, Hawaiian Department, to prevent such invasion;

And, pursuant to the same section, I do hereby suspend the privilege of the writ of habeas corpus until further notice;

And, pursuant to the same section, I do hereby place the said territory under mar-

And I do hereby authorize and request the Commanding General, Hawaiian Department, during the present emergency and until the danger of invasion is removed, to exercise all the powers normally exercised by me as Governor;

And I do further authorize and request the said Commanding General, Hawaiian Department, and those subordinate military personnel to whom he may delegate such authority, during the present emergency and until the danger of invasion is removed, to exercise the powers normally exercised by judicial officers and employees of this territory and of the counties and cities therein, and such other and further powers as the emergency may require;

And I do require all good citizens of the United States and all other persons within the Territory of Hawaii to obey promptly and fully, in letter and in spirit, such proclamations, rules, regulations and orders, as the Commanding General, Hawaiian Depart-

ment, or hip-subordinates, may issue during the present emergency. IN WITNESS WHEREOF, I have hereunto set my hand and caused the seal of


