The Chairman called the meeting to order to take final action on the bills that had been previously heard.

Attention was turned to HB 2993 which would repeal statutory sections relating to taxation and the State Department of Revenue. Senator Bogina presente an amendment to this bill which would establish the following divisions within the Department of Revenue: Division of Collections with a Director of Collections, Division of Operations with a Director of Operations, and a Division of Planning and Research with a Director of Planning and Research. All these directors would be appointed by the Secretary of Revenue and serve at the pleasure of the Secretary of Revenue. After some discussion a motion was made by Senator Bogina and seconded by Senator Strick to accept the amendments to this bill. Motion carried. A motion was then made by Senator Francisco to recommend HB 2993 favorable for passage as amended. This was seconded by Senator Hoferer and the motion carried.

HB 3008 relating to health and environment was recommended as favorable for passage in a motion made by Senator Hoferer. This was seconded by Senator Francisco and the motion carried.

The committee then looked at <u>HB 3030</u> concerning the Behavioral Sciences Regulatory Board. A motion was made by Senator Bogina to reinstate the language for the Regulatory Board and remove the language for the Masters of Psychology. This motion was seconded by Senator Strick and carried. A motion was then made by Senator Bogina to recommend HB 3030 favorable for passage as amended. A seconded was made by Senator Strick and the motion carried.

HB 3031 regulating professional counselors and establishing advisory committees on professional counseling was brought up for discussion. Senator Bogina made a motion to recommend this bill as favorable for passage with a seconded by Senator Strick. Motion carried.

The barber bill, <u>HB 2660 was recommended for passage in a motion made by Senator Francisco.</u> Senator Strick seconded this and the motion carried.

Attention was turned to $\underline{\text{HB 3105}}$ relating to the Kansas Statutes Annotated. A motion was made to recommend this bill as favorable for passage by Senator Bogina and seconded by Senator Hoferer. Motion carried.

......The classes and titles so specified and described shall be used for (a) original appointments, (b) promotions, (c) payrolls and (d) all other records affecting the status of persons in the classified service. but in no case shall any change in job class, title or function be used to require an employee in the classified service to assume significantly greater job duties without a commensurate change in salary.
