S.B. 466 - Concerning counties; relating to the Johnson County park and recreation district. The bill was co-sponsored by Senators; Bogina, Allen, Bond, Burke and Langworthy.

The Chairman called on Senator Bogina to explain the bill.

Senator Bogina stated S.B. 466 would allow Johnson County the opportunity to cooperate with Miami County in the operation, improvement and maintenance of the Hillsdale State Park, and to adopt and enforce rules and regulations for the operation of the park. The county commissioners of these counties have an agreement to support this recreation facility. There is a Hillsdale Recreation Authority that has been setup to operate the park.

Senator Allen and Senator Langworthy spoke in support of the bill and asked the Committee to report it favorably.

John Strickler, representing the Governor's Office, spoke in support of the bill.

Gerry Ray, Intergovernmental Coordinator, for Johnson County, stated the counties have worked out their differences on the park issue, and Johnson County supported the bill.

Staff presented an amendment that would clarify the language in the bill. (Attachment I)

Senator Ehrlich moved to adopt the proposed amendment. The motion was seconded by Senator Bogina. The motion carried. Senator Ehrlich moved to report S.B. 466, as amended favorable for passage. The motion was seconded by Senator Daniels. The motion carried.
