Senator Morris made the motion to adopt the amendments as presented. Senator Salisbury seconded the motion. After some discussion concerning the complexities and large number of changes the second and the motion were withdrawn. It was decided to look at the changes suggested by the Board of Healing Arts page by page, also various changes would be adopted by consensus of the committee.

## Senate Bill 603

Page 1, changes proposed in board's balloon bill accepted. Page 2, changes proposed in the Board's balloon bill accepted. Page 11, Fees addressed are as follows: 1) accepted as shown in balloon bill, \$150.00; 2) accepted as shown in balloon bill, \$150.00; 2) accepted as shown in balloon bill, \$150.00; 5) The concensus of the committee was that the proposed fee increase of \$100 be reduced to \$50 and "annual" be restored; 6) The motion was made by Senator Reilly to set the fee at \$100.
