The Vice-Chairman, Senator Werts, called the meeting to order.

INTRODUCTION OF BILLS

Senator Johnston moved, Senator Gaines seconded, for the introduction of the following bills:

- 7 RS 2746 An act concerning Pawnee Rock historical state park; authorizing the secretary of the state historical society to negotiate with representatives of the national park service concerning such state park.
- 7 RS 2734 An act relating to deferred compensation plans; transferring certain functions of the director of accounts and reports.

The motion carried on a voice vote.

HB 2808 - Appropriations for FY 1989, general government agencies of the executive branch.

The members of the Subcommittee reviewed the Senate Subcommittee Report on HB 2796, the supplemental appropriations bill and HB 2808, the FY 1989 general government appropriations bill. During discussion regarding Section 14, the Kansas Commission on Veterans Affairs, FY 1989, Senator Feleciano offered a motion to amend the Senate Subcommittee Report to include 2.0 FTE positions as recommended by the House in addition to the funding. Senator Talkington made a substitute motion to amend the Senate Subcommittee Report to include the 2.0 FTE positions and the required funding and delete the addition of\$20,000 to professional services for a contracted study to address the needs of aging veterans. Senator Gaines seconded the motion and it passed on a voice vote.

In regard to the Kansas Soldiers Home, FY 1989, Senator Feleciano moved, Senator Winter seconded, the addition of language instructing the investigation into the use of inmate labor for razing of the 13 cottages. The motion carried on a voice vote.

Senator Winter offered a motion to amend the Senate Subcommittee Report on HB 2808, Bill Section 19, FY 1989, Senate Subcommittee Recommendation number 12, for the addition of \$150,000 from the EDIF for an Industrial Liaison program by adding a proviso requiring KTEC to submit a specific plan for the program to the Joint Committee on Economic Development before they actually encumber or expend these funds. The motion passed on a voice vote.

In regard to Senate Subcommittee Recommendation number 18, FY 1989,

KTEC, Senator Winter suggested the possibility of an informal subcommittee to meet with the Division of Budget, the Division of Accounts and Reports, KTEC and Department of Commerce to look at the difficult issue of transfers being made from the Lottery to the EDIF and then to the agency. More flexibility is needed in making the transfers. Senator Winter explained that this is an issue the Subcommittee did not have a chance to study in any depth.

Senator Winter moved, Senator Feleciano seconded, the adoption of the Senate Subcommittee Report on HB 2796, supplemental appropriations bill, and HB 2808, FY 1989 appropriations bill, general government agencies of the executive branch, Section two through 19. The motion carried on a voice vote.

Senator Felecian moved, Senator Winter seconded, to recommend HB 2808 favorably as amended. The motion carried on a roll call vote.
