HB 2794 - Appropriations for FY 1989, state board of regents and higher education institutions.

Senator Kerr reviewed Sections 9 and 11, pertaining to Wichita State University and Kansas Technical Institute, of the Senate Subcommittee Report on HB 2794, the appropriations bill, and HB 2796, the supplemental appropriations bill.

Senator Kerr moved, Senator Johnston seconded, to accept the Senate Subcommittee Report regarding WSU and KTI. The motion carried on a voice vote.

Senator Winter reviewed Sections two, five and six, Fort Hays State University, Emporia State University, and Pittsburg State University respectively, of the Senate Subcommittee Report on HB 2794 and HB 2796.

In regard to FHSU, Senator Gannon moved, Senator Kerr seconded, to include the \$350,000 recommended in the House recommendation as recognition that FHSU lags seriously behind its peers. Following discussion, the motion failed on a tie vote.

In regard to PSU, Senator Gaines moved, Senator Doyen seconded, to insert \$50,000 for the public radio station operating grant. The motion carried on a voice vote.

In regard to ESU, <u>Senator Winter moved</u>, <u>Senator Gannon seconded</u>, to accept the <u>Senate Subcommittee Report on Emporia State University</u>. The motion carried on a voice vote.

Senator Doyen reviewed the section relating to the University of Kansas contained wihtin Senate Subcommittee Report on SB 2794 and HB 2796. Senator Doyen moved, Senator Johnston seconded, the acceptance of the Senate Subcommittee Report on the University of Kansas. The motion carried on a voice vote.
