
The minutes of the meeting on March 2nd were presented for approval. Representative Empson moved the minutes be approved and this was seconded by Representative Wilbert. The motion carried.

Senate Bill 111

Our office asked for the introduction of SB 111 to fulfill the requests of the Federal Voting Assistance Program, a division of the U.S. Department of Defense.

The bill will mandate several ideas which are already in use in the state of Kansas. The 45 day deadline to send federal service ballots, and the single application for a ballot for both elections are practices already encouraged by our office.

This same idea was passed by both houses last year but failed to become law because the presidential preference primary was amended into the bill.

In addition, the bill cleans up K.S.A. 25-2708 to allow for the destruction of school ballots in the same manner as city ballots.

I ask that you recommend SB 111 favorably for passage.

Senate Bill 248

Thank you Mr. Chairman and members of the committee.

The Secretary of State's office asked for the introduction of SB 248 in order to clean up a discrepancy in the Kansas election laws.

Currently, in order for any voter who needs assistance in voting to cast a ballot, they must complete a notarized document along with the person offering assistance. Many times, the person needing assistance in voting, is unable to get a document notarized, therefore, possibly denying them the right to vote.

We are asking in SB 248 to allow the requirement for a notary to be changed to a requirement for a written statement similar to the statements used on all other election documents.
