The House Election Committee was called to order by Chairman Kenneth R. King on Tuesday, March 28th, 1989 at 9:08 a.m.

The order of business for the day was discussion and final action on all previously heard bills.

SB 111 was the first bill to be presented. Representative Sawyer made a motion the bill be passed favorably. Seconded by Representative Baker. The motion carried.

The Chair then offered SB 248 for discussion. Representative Sawyer made a motion that this bill be passed favorably. Seconded by Representative Baker. The motion carried. Representative Shallenburger made a motion that SB 248 be placed on the Consent Calendar. Representative Lucas seconded. The motion carried.

Representative Lucas made a motion that SB 112 be passed favorably. This was seconded by Representative Cates. Representative Sawyer made a substitute motion that HB 2241 be amended into SB 112. This was seconded by Representative Sebelius.

After discussion a vote was taken on the substitute motion and this failed on a vote of 9-8. A vote was then taken on the original motion to pass the bill out favorably and this carried.

SB 247 was the next bill to be presented to the committee for discussion. Representative Sawyer made a motion that the bill be passed favorably. This was seconded by Representative Shallenberger. The motion carried.

On opening SB 307 for discussion Representative Baker made a motion to amend the bill, striking "city" after the candidate's name on the ballot (line 201 to 205). This was seconded by Representative Cates. A vote was taken on this amendment and it carried. A motion was made by Representative Lucas to pass the bill out of committee as amended. This was seconded by Representative Shallenburger. The motion carried.

Representative Lucas made a motion to pass SB 294 out of committee favorably. This was seconded by Representative Empson. A substitute motion was made by Representative Baker and seconded by Representative Johnson that this bill be tabled.

A vote was cast on the substitute motion and the motion carried.  $\underline{\text{SB }294}$  was tabled.

Representative Foster made a motion that SB 117 be passed. This was seconded by Representative Lucas. The motion carried.
