## TESTIMONY IN SUPPORT OF PROPOSED PLANNING LEGISLATION

Price Banks, Chair, Legislative Study Committee, Kansas Chapter, American Planning Association

Our study committee was formed years ago with the mission of examining planning related statutes in Kansas, and offering recommendations for updating these statutes.

The existing statutes are antiquated. Some have been around since the early part of this century, and they have been amended many times over the years. Nevertheless, they lack modern planning methodologies such as transfer of development rights or planned districts. Many of the provisions of the statutes are confusing or hard to understand. The law, as we thought we knew it, has been changed by the courts in some instances, and there is confusion regarding procedural requirements.

Our primary interest was in clarifying and simplifying the language in the statutes. We seek uniformity between provisions within each statute and between statutes applying to cities and counties.

As we began our task, we realized that we planners would need the support of other interest groups if we were to succeed. We enlisted the assistance of the Kansas League of Municipalities, the Kansas Home Builders Association, and the Kansas Manufactured Housing Institute. Therefore, representatives of each of those agencies sat on the study committee. The proposed legislation is the result of the work of that committee.

The legislation is relatively complex, and technical in some areas. We believe it would benefit from study by an interim committee. We are willing to pledge technical support for that committee through our membership. We will arrange to have members of our organizations available to work with the committee and provide additional staff support.

We believe all local government will benefit from the enactment of clear, contemporary, uniform laws relating to planning in Kansas.
