Five committee bills were introduced.

A motion was made by Representative Fuller and seconded by Representative Grotewiel to introduce a bill to give the Secretary of Revenue authority to compromise tax liabilities. The motion passed.

A motion was made by Representative Fuller and seconded by Representative Pottorff to introduce a bill on exemptions of LP fuel for city vehicles. The motion passed.

A motion was made by Representative Wagnon and seconded by Representative Spaniol to introduce a bill to increase the homestead exemption and provide property tax relief for effects of reappraisal.

A motion was made by Representative Roe and seconded by Representative Dean to introduce a bill for collection of sales tax on situs motor vehicles. The motion passed.

A motion was made by Representative Pottorff and seconded by Representative Wagnon to introduce a bill on tax credits for home care for the elderly. The motion passed.

Secretary of Revenue Ed Rolfs testified in support of <u>HB 2033</u>, the Kansas Taxpayer's Bill of Rights. We will approach our tax collection duties with fairness and common sense. Taxpayers will be informed of their appeal rights within our tax system and can rely on advice from the Department of Revenue. If there is negligence on the part of a Department employee in assessing tax due or notifying a taxpayer of the amount owed, interest will not be charged for the period of delay. Liens against a taxpayer's property will be released within 30 days of payment of amount due. Should a case arise where the Department of Revenue asserts a claim which is without a reasonable basis in law or fact, and a taxpayer is forced to litigate a matter unnecessarily, attorney fees and related expenses may be awarded to the taxpayer. The Kansas Department of Revenue's mission is to make the state tax system fair, efficient, stable, competitive and understandable. (Attachment 1)

Dr. George Goebel, a member of the AARP State Legislative Committee, testified in behalf of $\underline{\text{HB}}$ 2033. We commend Gov. Hayden for including support in his "State of the State Message" to the Ks. Legislature for enactment of a taxpayer's "Bill of Rights" and to the Committee on Taxation for introduction of this proposed legislation. (Attachment 2)

I appreciate the opportunity to appear before you today in support of House Bill 2033, the Kansas Taxpayer's Bill of Rights. As Governor Hayden said in his State of the State Message "This law will formalize our pledge to all Kansans that we will approach our tax collection duties not only with vigor, but with fairness and a large measure of common sense."

This bill would provide Kansas citizens the following safeguards:

- 1. Taxpayers will be adequately informed of their appeal rights within our tax system.
- 2. Taxpayers can rely on advice they receive from the Department of Revenue.
- 3. The Department of Revenue will not evaluate its' employees performance base on amounts of assessments made.
- 4. If negligence on the part of a Department employee causes undue delay in assessing tax due or notifying a taxpayer of the amount owed, interest will not be charged for the period of the delay.
- 5. Liens against a taxpayer's property will be released within 30 days of payment of the amount due.
- 6. Should a case arise where the Department of Revenue asserts a claim which is without a reasonable basis in law or fact, and a taxpayer is forced to litigate a matter unnecessarily, attorney fees and related expenses may be awarded to the taxpayer.

The mission of the Kansas Department of Revenue is to make the state tax system fair, efficient, stable, competitive and understandable. We believe that our system of voluntary compliance is greatly enhanced if taxpayers are informed about the tax law and how our system works. The taxpayer bill of rights will formalize and codify our belief that taxpayers deserve to be informed and dealt with fairly.
