It is in the opinion of the Kansas Department of Revenue that the present service fee County Treasurers are receiving is not sufficent for covering the operation costs of County Motor Vehicle Offices.

The following list includes some additional responsibilities and duties which represent added costs that have been assigned to County Treasurers without additional compensation.

- 1. Additional office supplies including paper, printer ribbons, tapes, rubber stamps and etc. are needed because of the implementation of VIPS.
- 2. With the implementation each year of new legislation additional duties, forms and/or affidavits are required by the Kansas Dept. of Revenue.
- 3. County Treasurers are now responsible for dispensing Special Tags, which had not previously been required.
- 4. Applications for secured, reissue and duplicate titles are now processed through the Treasurer's offices.
- 5. Daily reports are now required to be mailed daily instead of weekly which incurs an added expense.
- 6. As of July 1,1989, the Department of Revenue will no longer be furnishing envelopes for mailing registration receipts and decals. County Treasurers will be responsible for purchasing the envelopes.
- 7. Additional enployees are required in processing the mail for registration renewals.
- 8. Within a few weeks Handicap Placards will be dispensed by the County Treasurer's Offices.
- 9. Updating of records for VIPS system is now an added responsibility of County Treasurers.
