The meeting was called to order by Senator Dave Kerr, Chairman.

Lynne Holt, Legislative Research, presented to the Committee an overview of  $\underline{\text{House Bill 2485}}$ , trade fair assistance. Each member was also given copies of letters from various companies supporting the bill (Attachment 1).

Charles Warren, President, Kansas Inc. presented written testimony to the Committee (Attachment 2). He stated one of the greatest accomplishments in this session will be moving Kansas into the forefront of states playing a major, innovative role in international trade and exports. He also pointed out that the Kansas Inc. Board of Directors recommended strongly that the Legislature establish both an export financing program and trade fair assistance program. Senator Francisco questioned the dollar amount in the bill (\$3,500 per event; \$7,000 per year per company) for eligible expenses. Mr. Warren felt that amount would be useful for smaller companies and was appropriate. He stated another good feature of the bill was the requirement for an annual report. Senator Kerr asked Mr. Warren what his opinion was regarding distributorship types of activities as described in lines 68 and 101. Mr. Warren felt the thrust of the bill supported the value added processing, and that's where our emphasis should be.

Senator Francisco asked about the Governor's recommendation for funding of this bill. The Chairman stated that this bill would be ideal for EDIF money. He felt that if we want to fund this, there would be EDIF money available. The suggested level is \$100,000 for the first year.

Senator Francisco moved that the words "packaged and sold or" be removed from lines 68 and 101 in the bill. Seconded by Senator Salisbury. Motion carried, language is removed.

Senator Feleciano stated that perhaps the July 1, 1989 date needs to be changed to take advantage of two trade fairs coming up this summer. Senator Feleciano moved that the bill be amended to take effect upon publication in the Kansas register and be recommended favorably for passage.

Senator McClure felt there was a need to clean-up some of the language of the bill. There was a substitute motion by Senator McClure, seconded by Senator Feleciano to clean up the language of the bill. Motion carried, changes adopted.

Senator Feleciano moved to amend the bill to make the act effective upon the publication of the Kansas Register and also moved to recommend the bill favorably as amended. Motion carried, bill amended.

There being no further business the meeting was adjourned.



# House Bill No. 2485 Trade Fair Assistance for Small Businesses

#### House Bill 2485

Senator Kerr, members of the Committee, I am Charles Warren, President of Kansas Inc. I appreciate this opportunity to testify in support of House Bill No. 2485 that would establish a trade fair assistance program in the Kansas Department of Commerce.

The issue of <u>Business Week</u> dated February 27 carried a cover story titled: "TRADE: Will We Ever Close The Gap?" One of the articles inside proclaims: "The Little Guys are Making It Big Overseas: Midsize companies in export niches could help ease the trade deficit in the long run."

The article notes that: "86,500 companies have occasional foreign sales but would like to make more. Spurred by the cheap dollar, thousand of other companies with no export activity are starting to learn the ropes. Almost all these players have sales of less than \$300 million a year."

The article goes on to say that: "this broad gearing up to export by thousands of smaller companies is just in its early stages and will help keep the growth in U.S. exports strong." The former U.S. trade representative is quoted as saying: "The growth in these smaller companies is where the growth in our country is."

The article also reports on some of the new export initiatives underway in the states of Massachussetts, Minnesota, and Oregon.

I think our greatest accomplishment in this 1989 legislative session for economic development will be in moving Kansas into the forefront of states playing a major, innovative role in international trade and exports. We have already established a strong international trade and development division in the Department of Commerce and have set up trade offices in Europe and Asia. Secretary Harland Priddle and Division Director Harry Salisbury have made the goal of increasing Kansas exports a top priority and are providing effective and energetic leadership. In the Interim Session, the Joint Committee on Economic Development studied international trade intensively. One result was Senate Bill 21 to create a new export financing program.

The Kansas Inc. Board of Directors recommended strongly that the Legislature establish both an export financing program and a trade fair assistance program to provide the International Trade Division additional needed tools to increase foreign exports by small Kansas firms.

The combination of export finance and trade fair assistance will provide the Department of Commerce valuable tools to work with Kansas companies and provide them the type of direct assistance that can really make a difference. Commerce has done a good job in providing trade leads, information and training through seminars, and foreign representation. Senate Bill 21 and House Bill 2485 will enable the Department of Commerce to move beyond advice and representation into proactive support of Kansas exporters and would-be exporters.

Section 6 requires the the Secretary of Commerce submit an annual report with information regarding effectiveness of trade show participation and is an important provision. Such information will be very helpful in the evaluation of this program and will enable the Legislature to judge the program's success and the adequacy of its funding in future years.

I am excited about the new initiatives that both the Senate and House Committees are developing in the area of international trade. I think we now have the opportunity to provide major and significant help to small business in Kansas in moving them into international exports and global markets.
