SB 52 - After calling the meeting to order, Vice-chairperson Sheila Frahm noted that yesterday's presentation on Education Update-Preschool Handicapped provided background information for SB 52 to be heard in Committee today. She then called upon proponent Mr. Bill Musick, Legislative Committee Chairman, State Board of Education. Mr. Musick explained that the primary purpose of SB 52 is to increase membership of the Coordinating Council on Early Childhood Developmental Services from seven to fifteen members in order to bring Kansas into compliance with P.L. 99-457. (Attachment 1)

Ms. Judy Moler, Executive Coordinator, Coordinating Council for Early Childhood Developmental Services, provided additional information to Committee members during discussion of SB 52. Main focus of the dicussion related to the lack of representation of the minority party on the Council. Ms. Moler, responding to a question, stated that the Coordinating Council takes no position on SB 52.

Hearing no further requests from conferees, Vice-chairperson Frahm announced that the hearing on SB 52 was concluded.

SB 99 - Vice-chairperson Sheila Frahm recognized Mr. Norman D. Wilks, Director of Labor Relations, Kansas Association of School Boards. Mr. Wilks, testifying in support of SB 99, stated that the purpose of SB 99 is to extend the statutory impasse date, if required. Mr. Wilks proposed a change in the language of the bill, and this is noted in his testimony in Attachment 2.

Mr. Gerald W. Henderson, Executive Director, United School Administrators of Kansas, stated that his organization supports the provision of SB 99. (Attachment 3)

Hearing no further requests from conferees, the Vice-chairperson announced that the hearing on SB 99 was concluded.

Senator Allen moved and Senator Karr seconded the motion that minutes of the meeting of February 14 be approved. The motion carried.

Chairman Harder then referred the Committee's attention to SB 12, relating to the establishment of the Kansas ethnic minority scholarship program. He informed the Committee that Ms. Avis Swartzman, revisor of statutes, had prepared written copies (Attachment 4) of proposed amendments which had been requested by Ms. Clantha McCurdy and Mr. Ted Ayres of the Board of Regents.

Following discussion of the proposed amendments, it was the general consensus of the Committee to request Ms. McCurdy and Mr. Ayres to return for additional Committee questions before taking action on SB 12.

The Chairman called the Committee's attention to SB 99 and asked the Committee's pleasure. Senator Langworthy moved to amend SB 99 as suggested by Mr. Norman Wilks. (see Attachment 2) The motion was seconded by Senator Montgomery, and the amendment was adopted. Senator Langworthy then moved that SB 99, as amended, be reported favorably for passage. Senator Montgomery seconded the motion, and the motion carried.

The Chairman announced that the Committee will meet tomorrow in room 313-S in order to accommodate the statewide members of the Kansas Association of School Boards who will be in town to attend their annual Governmental Relations Seminar this week. He then adjourned the meeting.

My name is Bill Musick, Legislative Committee Chairman of the State Board of Education. It is a pleasure for me to appear before this Committee on behalf of the State Board.

Senate Bill 52 increases the membership of the Coordinating Council on Early Childhood Developmental Services from seven to fifteen members and requires that the funding of this Council be from federal funds made available to the state for early childhood services for the handicapped. Currently, funds for early childhood services are made available to the State Department of Eduction and the Department of Health and Environment.

Public Law 99-457 provides for a Coordinating Council to advise and assist in the implementation of a comprehensive delivery of services to handicapped children ages zero to three. The Council must include three parents of young handicapped, three providers of early intervention services, one state legislator, one person involved in personnel preparation, and seven others representing appropriate agencies. Listed below is a comparison of the current Council membership and the recommendations of Senate Bill 52.

Mr. Chairman and members of the committee, on behalf of the three hundred one unified school boards of education which are members of the Kansas

Association of School Boards, we wish to express our appreciation to the committee for introducing Senate Bill No. 99.

We support the changes in subsection (n), lines 131 to 135 of the bill which extends the statutory impasse date, if required. The extension of the deadline will avoid the artificial pressure of impasse prior to the time the parties may actually be unable to reach an agreement.

We would propose a change in the bill as printed in lines 55 and 56. We request the committee to reinstate the language "with respect to the terms and conditions of professional service." This reinstatement of existing language we believe is necessary to maintain the current status of the role of professional employees' organizations in the negotiations process.

We would appreciate your favorable consideration of Senate Bill No. 99 with the change as suggested. I would be happy to answer any questions you may have regarding the bill or the proposed change.
