Chairman Reilly called the meeting to order.

Senator Vidricksen requested introduction of a proposal which would change the effective date in  $\underline{SB}$   $\underline{61}$  for publication in the register and clean up the bill. Senator Bond moved the proposal be introduced and Senator Morris seconded. The motion passed.

Senator Strick moved the bill be referred to the committee of the whole. Senator Vidricksen seconded and the motion passed.

Senator Vidricksen explained the subcommittee report on  $\underline{\text{SB 69}}$  and  $\underline{\text{Sub. for}}$   $\underline{\text{HB 2172}}$  (Attachment 1).

Senator Bond moved Sub. for HB 2172 be reported favorable for passage. Senator Morris seconded and the motion passed.

The meeting was adjourned at 2:30.

## SUBCOMMITTEE REPORT

The subcommittee on S.B. 69 and Substitute for H.B. 2172 met on April 5, 1989, to consider several issues relating to bingo games raised by conferees who met with the Senate Committee on Federal and State Affairs. Senators Vidricksen, Yost, and Walker were present, along with staff and several other persons interested in games of bingo.

Following discussion, the subcommittee decided to recommend that Sub. for H.B. 2172 be further amended in subsection (f) of K.S.A. 79-4706 (page 2 of the bill) to change the restriction on the limitation of the aggregate value of all prizes, including the retail value of merchandise, that may be awarded on a single day from \$1,200 to \$1,500. No change is recommended in subsection (h) which limits the amount of the prize for any one jackpot or special game.

The subcommittee also recommends that the statute be amended in subsection (q), page 3, to raise the number of days that bingo may be conducted on any premises from three to four calendar days in any one week with the addition of a new limitation that prohibits conducting games on the premises on a consecutive Saturday and Sunday.

The subcommittee recommends (1) that the provisions of subsection (s) be deleted, with the exception of the first word, and new language be added that restricts the issuing of a license for <u>leased</u> premises located within 1,000 feet of other <u>leased</u> premises for which a current license is in effect; (2) a new subsection (t) be added to the statute that speaks to the problem that has been raised by the purchase of new premises from which bingo will be conducted on owned premises in Topeka; and (3) that the remaining subsections be renumbered.
