SB 793 - Omnibus Appropriations Bill

The Committee took up consideration of the differences in Senate and House actions on \underline{SB} 793 following the "1990 Omnibus Bill Explanation" prepared by the Legislative Research Department (Attachment 1).

- Sec. 2 Department of Revenue To concur with the Senate position on Item 8, Representative Fuller moved to authorize the expenditure of \$444,000 funded from funds budgeted as aid to counties for KSCAMA software enhancements. Representative Kline seconded. Motion carried.
- Sec. 7 State Board of Healing Arts Representative Shriver moved to delete Sec. 7 from the bill. Representative Pottorff seconded. Motion carried.
- Sec. 9 Department of Education Representative Wisdom would like to fund special education at the 95 percent level as the Senate has recommended in Item 4. Representative Wisdom moved to concur with the Senate in adding \$2,400,299 State General Fund for special education in FY90. Representative Francisco seconded. Staff advised that the federal mandate of special education for three year olds is effective 7-1-91. The motion carried. Staff advised on Item 2, the correct amount of additional general state aid to fund the Senate version of the SDEA is \$7,979,313. The House has not added any money in the Omnibus bill for school finance.
- Sec. 12 State Board of Agriculture The Committee did not recommend restoring \$90,000 in oil overcharge funds to the Board of Agriculture in Item 6. The Committee did not recommend the addition of \$126,604 State General Fund for GIS in Item 7.
- Sec. 14 State Historical Society Representative Hoy moved to concur with the Senate in adding reappropriation language for the Tobias historic site account in Item 3. Representative Hensley seconded. Motion carried.
- Sec. 16 Public Broadcasting Commission The Committee did not recommend adding \$100,000 in FY91 for KOOD in Item 1.
- Sec. 21 Department of Administration The Committee was advised that the Joint Committee on State Building Construction reviewed, at length, the purchase of the Victory Life property. Representative

Kline moved to concur with the Senate position on Item 3 authorizing the State Finance Council to approve the purchase of the Victory Life Property. Representative Heinemann seconded. Motion carried.

- Sec. 24 Department of Health and Environment Item 2 Representative Wisdom moved to reduce KDHE's budget in AIDS Education and Risk Reduction by \$15,623 and to add that amount to the budget of the Kansas State School for the Visually Handicapped. Representative Lowther seconded. Motion carried.
- Items 4 and 5 The Committee did not recommend Item 4. Representative Turnquist moved to approve Item 5 adding \$400,000 State General Fund in FY91 for the purchase of vaccine. Representative Hensley seconded. Motion failed. The Committee did not recommend Item 5.
- Item 6 Representative Pottorff moved to concur with the Senate in adding \$50,000 State General Fund in FY91 for genetics counseling contracts with KUMC and Wesley Hospital in Wichita. Representative Fuller seconded. Motion carried.
- Item 10 Representative Lowther moved to approve the technical adjustments in Item 10. Representative Wisdom seconded. Motion carried.
- Items 11 and 12 The Committee did not recommend Item 11 adding \$100,000 to the Adolescent Health Promotion Program. Representative Lowther moved to concur with the Senate on Item 12 creating a no-limit Pollution Abatement Gift Fund. Representative Wisdom seconded. Motion carried. Representative Gatlin noted that a major policy decision is involved in accepting a gift from a company to promote special treatment.
- New Item 13 Staff requested authorization to make a necessary technical adjustment pertaining to the Radioactive Waste Compact to make <u>HB 2729</u> conform with Legislative intent. Representative Wisdom moved to approve the requested technical adjustment. Representative Mead seconded. Motion carried.
- New Item 14 Staff advised that per the passage of $\frac{HB}{2594}$, the agency is requesting \$49,000 State General Fund in FY91 to hire an Education Program Specialist to study, develop, implement, and approve a 40-hour personal care attendant curriculum. Representative Lowther's subcommittee will review this request and offer a floor amendment if recommended.
- New Item 15 Representative Lowther stated <u>HB 2915</u> enacts a program for early identification of hearing-impaired infants. Representative Lowther moved to add \$9,085 State General Fund in FY91 for the hearing-impaired infants program for printing costs and office supplies in KDHE. Representative Pottorff seconded. Motion carried.
- Sec. 25 State Corporation Commission The Committee did not recommend Item 1, which is GIS funding.
- Sec. 27 Topeka State Hospital
- Sec. 28 Osawatomie State Hospital
- Sec. 29 Larned State Hospital Rainbow Mental Health Facility
- Staff advised that the categorical aid rate for FY91 will be \$17,437. The House would need to make additions to these budgets to fund this rate. Representative Lowther moved to add \$762 for Larned, \$1,114 for Osawatomie, \$1,296 for Rainbow and \$3,323

- Sec. 30 Commission on Veterans Affairs/Soldiers' Home Representative Goossen moved to concur with the Senate position on Item 1.

 Representative Pottorff seconded. Motion carried.
- Sec. 31 Department of Commerce The Committee did not recommend Item 6 adding \$1 million from the EDIF for the Community Strategic Planning Assistance Program. On Item 5, Representative Helgerson made the point that when the transfer of housing programs from SRS to the Department of Commerce began three years ago, there was no talk of positions; however, now 3½ positions are involved. The Committee did not recommend Item 7.
- Sec. 32 State Conservation Commission Representative Turnquist moved to include \$3,300 in FY91 for increased rent costs to concur with the Senate on Item 1. Representative Vancrum seconded. Motion carried.
- Sec. 33 Kansas Water Office The Committee did not recommend Item 2 regarding GIS. Representative Shriver would support approving the GIS funding from fee funds in the KCC budget and the Department of Wildlife and Parks. Representative Vancrum does not agree with starting a program of the potential magnitude of GIS with non-State General Fund monies. Representative Gatlin moved to delete \$5,000 in Item 1 from the House position. Representative Moomaw seconded. Motion failed.
- Sec. 36 Department of Corrections Representative Kline stated that the Joint Committee on State Building Construction recommended unanimously that the Santa Fe Building in Wichita be purchased for the Wichita Work Release Center. Representative Kline moved to approve Item 9 as recommended by the Senate. Representative Francisco seconded. Representative Kline stated the Department of Corrections is aware of possible contamination on this site and will have KDHE make an inspection before any acquisition is initiated. Representative Helgerson made a substitute motion to approve Item 9 with the provision that there would be an independent analysis of the site for contamination. Representative Wisdom seconded. The substitute motion carried.

Representative Heinemann suggested when the cost of the inspection is known, there may need to be an adjustment to the amount in this item during Conference Committee. Representative Helgerson urged the Department to contact the city fathers and attempt to work cooperatively with them when making a major change such as moving the Work Release Center or when planning to purchase other property in Wichita. In discussion of state responsibility if contamination is found on the site of the Santa Fe Trail Building, a member noted that the state has the option of not going through with the purchase or of establishing responsibility prior to taking title. Staff will advise the DOC of this discussion.

Items 10 and 11 - On Item 10, the \$248,813 for FY91 is to fund the Topeka Correctional Facility-West in Building 112. Representative Teagarden moved to approve \$248,813 for FY91 for the Topeka Correctional Facility-West. Representative Bunten seconded.

Motion carried. Representative Teagarden stated the asbestos removal in Item 10 and the lease termination in Item 11 regarding Building 321 will be discussed in Conference Committee when details of the plan are known.

- Item 12 The Committee did not approve this item for inclusion in the Omnibus bill.
- Sec. 41 Department of Wildlife and Parks The Committee did not recommend in Item 10 the addition of \$34,280 from the Wildlife Fee Fund in FY91 for GIS.
- Sec. 42 Winfield State Hospital and Training Center Sec. 43 - Parsons State Hospital and Training Center Kansas Neurological Institute

The adjustments needed in the mental retardation hospitals' budgets for the categorical aid rate are the addition of \$2,158 State General Fund to Winfield, \$2,256 to KNI and \$2,288 to Parsons. Also, due to increases in State General Fund amounts to Winfield and Parsons by the Governor, reductions of \$20,609 State General Fund at Parsons and \$20,556 at Winfield are available. Representative Vancrum moved adoption of all these adjustments. Representative Turnquist seconded. Motion carried.

- Sec. 44 Kansas State University Representative Solbach moved approval of Item 2. Representative Kline seconded. Motion carried.
- Sec. 45 University of Kansas Representative Goossen moved approval of Item 1 authorizing \$250,000 in bond financing for improvement of new University Press offices. Representative Shriver seconded. Motion carried. Representative Shriver distributed a letter from the Regents on the impact of the Committee's action in shifting funding of \$1 million from FY91 to FY92 for the new Regents Center (Attachment 2). Chairman Bunten suggested we consider this matter following completion of recommendations on SB 793.
- Sec. 47 Wichita State University Item Representative Brady moved to add \$120,000 State General Fund in FY90 for utilities. Representative Moomaw seconded. Motion carried.
- Item 2 Representative Chronister moved to approve Item 2 adding 35 FTE positions in FY91 funded from restricted use funds as recommended by the Senate. Representative Wisdom seconded. Representative Brady advised that the subcommittee looked at authorizing these positions on the initial budget review and they found that the University is hoping to receive federal funds for most of the positions. The Subcommittee recommends the University seek approval of the positions from the State Finance Council at the time federal funds are received. Representative Chronister withdrew her motion with the consent of the second, Representative Wisdom.
- Sec. 49 Legislature Regarding the addition in Item 1 of \$754,676 State General Fund in FY91 for computerization of redistricting of the Legislature, Representative Snowbarger appeared to explain this program. In 1992 the state will have to redistrict the House, Senate, Congress, and Board of Education, and four different databases will have to be used. Representative Snowbarger believes computers will be necessary in this process. He stated there is a not a no-cost option and he reviewed the costs of comupterization itemized in the Omnibus bill explanation of Sec. 49. The hardware package provides for two central computers and four work stations for each of the leadership offices. Representative Lowther asked if the state could contract with another state for these services and Representative Snowbarger feels this would not save money and could be more expensive. The proposed hardware could be compatible with DISC through networking devices.

Representative Chronister moved to approve this item for inclusion in the Omnibus bill. Representative Kline seconded. Motion failed.

Sec. 50 - Kansas Racing Commission - Representative Teagarden moved to approve the transfer of \$100,000 in FY90 from the State Racing Fund to the Racing Reimbursable Expense Fund. Representative Hoy seconded. Motion failed

Sec. 51 - Legislative Coordinating Council - Representative Teagarden moved that \$500,000 not be approved for a management study of SRS. Representative Kline seconded. Motion carried.

Regarding the Regents Center funding shift discussed in Attachment 2, Representative Vancrum moved to add \$75,000 State General Fund in FY91 for the Regents Center. Representative Kline seconded. Motion failed.

Representative Helgerson expressed concerns that the State Historical Society is requesting \$1.5 million for site and foundation work above the \$7.9 million appropriated last year for the Center for Historical Research. He noted a study is going to be done to determine whether the site is a floodplain and the implications of that. He questioned what might be the liability of the architects and engineers in this project. He would like a letter of explanation to the Legislature on these problems at some point. Chairman Bunten stated he shares these concerns.

Representative Vancrum expressed concern regarding the effect of the enrollment adjustment on Emporia State University. In 1986, Emporia State received a large negative adjustment and this year should have received \$707,000. Emporia State is down approximately \$900,000 under the current formula over the last eight years. As a result of Conference Committee action, the University is \$15,529 below the House Appropriations Committee position. Representative Vancrum moved to add \$135,350 to the Emporia State University budget. Representative Turnquist seconded. Motion failed. Representative Solbach moved to add approximately \$15,700 to the Emporia State budget. Representative Vancrum seconded. Representative Gatlin made a substitute motion to increase the enrollment adjustment by \$15,700 and reduce the fee release to Emporia State by the same amount. Representative Solbach seconded. Representative Gatlin withdrew the substitute motion with the consent of the second. On a show of hands on Representative Solbach's original motion, the motion carried.

Representative Heinemann moved to adjust the shrinkage rate at Fort Hays State University to 1.8 percent, which is the same as Emporia State. Representative Mead seconded. Representative Chronister advised that the Conference Committee, to address inequities, added \$50,000 to the budgets of Emporia, Fort Hays, and Pittsburg, and added \$100,000 to Kansas College of Technology. The motion failed.

Representative Francisco advised that in <u>SB 508</u> the Senate had approved a hold harmless program involving funding of \$1,150,000 for four districts--Derby, Augusta, and two others. The House Education Committee did not approve this program. Representative Francisco would like these funds that were earmarked for the four districts to be distributed to seven districts experiencing a 10 mill increase, which put their rates over 65 mills. The seven districts are Valley Center, Maize, Westmoreland, Holton, Rose Hill, Goessel, and Basehor. In effect, this proposal would

Chairman Bunten announced we will have a meeting on Monday, April 30, to hear bills still on our calendar. Representative Hoy requested consideration of SB 567. The Chairman stated on the basis of the authority the Committee gave him to introduce appropriations bills, he introduced HB 3120. He requested the Committee to ratify his action. Representative Vancrum moved to ratify and approve the introduction of HB 3120 needed to correct a defective document signed by the Governor. Representative Teagarden seconded. Motion carried.

The meeting was adjourned at 4:25 p.m.

REGENTS CENTER FUNDING

On April 16, the House Appropriations Committee adopted a motion to include in the Omnibus Bill a section that would delay from Fiscal Year 1991 to Fiscal Year 1992, the transfer of \$1,000,000 from the State General Fund to the construction account for the new Regents Center. While it was not the intent of the Committee to either delay the project or reduce its scope, this action will have an impact on the financing of the facility.

A year ago, the Governor recommended and the Legislature authorized the University to construct a new Regents Center to replace the facility which has operated since 1975 in a former elementary school. The University secured a gift of 37 acres on which to locate the new facility. The total cost of the project is \$6,000,000 of which \$5,000,000 would be for construction and \$1,000,000 for site development. The Legislature provided a total of \$2,000,000 from the State General Fund; \$1,000,000 in FY 1990 and an additional \$1,000,000 in FY 1991.

The initial \$1,000,000 was to be used to employ architects, and do necessary site work. The construction, which will be bid late summer, would be financed by a bond issue with the debt to be retired from a variety of sources including additional student fees, private gifts of \$1,000,000, proceeds from the sale of the old facility, and rental of space to University services that currently exist in other Kansas City locations. The financing package has been carefully devised and continuously reworked to insure that the debt service could be managed. Bond counsel has been appointed and has met with the University on several occasions to explore the most advantageous approach to financing the facility.

At this time, the University is considering two options, both of which would be impacted by the House Committee action. One approach would be to issue \$5,000,000 in bonds. The second State transfer of \$1,000,000 would be invested and the principal together with interest earnings would be utilized over a 20 year period to assist in the annual debt service. The delay of this second transfer would effectively reduce the income available to the University for debt service by more than \$75,000 placing a greater strain on the other resources the University has available to finance this project. The second option, one initially recommended by the bond counsel, is to utilize the second \$1,000,000 as a part of the construction budget and reducing the bond issue to \$4,000,000. The action by the House Committee would effectively remove this option and force the institution into the issuance of \$5,000,000 in bonds.

The House action is an effort to enhance balances in the State General Fund at the end of FY 1991. It would be our observation that the balance at the end of FY 1991 is not the critical issue, but rather the financial condition of the State in FY 1992. Delaying this second transfer a year doesn't lessen that problem, and we would respectfully urge the Legislature to leave the funding approved a year ago in place.
