The meeting was called to order by Chairman Crumbaker hearings were opened on SCR 1631, requesting legislative study on interaction between schools and other social service agencies.

Senator Frahm testified in support of <u>SCR 1631</u>. She read from the bill..."a special committee to study and review the following: The various state and communitybased agencies that provide social services for children and the ways the mission and role of such agencies impact the mission and role of schools, ways of facilitating open and frequent communication and fostering cooperation between schools and other social service agencies...". Senator Frahm said in recognition that the educational system consists of both schools and the community at large it is appropriate to put together a committee to review how communication between the schools and these social services can be improved. Senator Frahm said two other bills, <u>SB 522</u> and <u>HB 2668</u> are addressing the same issue.

Mr. Henderson spoke in support of \underline{SCR} 1631. Mr. Henderson said frustration often results from the lack of communication between schools and SRS and other agencies designed to help children and families. (Attachment 1)

Mr. Reynolds spoke in favor of <u>SB 1631</u>. He said this type of study is needed to determine what possibilities exist for closer working relationships between non-educational agencies serving children and school districts. (Attachment 2)

Ms. Waide testified in support of \underline{SCR} 1631. She believes the special committee would be helpful in identifying problems encountered by educational and social service agencies in working together. (Attachment 3)

Hearings on \underline{SCR} 1631 were closed by the chairman and hearings were opened on \underline{HCR} 5057, requesting State Board of Education to study dual and multi-diploma systems.

Representative Bowden testified for <u>HCR 5057</u>. He said some states have provided for different curricular programs which lead to granting different types of diplomas. Representative Bowden feels our state would profit from a study of what other states are doing as we consider the issues of education in future sessions. (Attachment 4)

During the discussion of \underline{HCR} 5057 Representative Ramirez asked Ms. Connie Hubbell if the State Board of Education had taken a position on this bill. Ms. Hubbell replied that the State Board of Education did not have a position on \underline{HCR} 5057 at this time.

Representative R. D. Miller moved to pass out SCR 1631 favorably. Representative Lane seconded the motion. Representative David Miller offered a substitute motion to amend SCR 1631 on 1. 43 by inserting after the comma, "the costs of such state programs to determine if more cost effective methods or procedures should be instituted" Seconded by Representative Williams. Motion carried. Representative R. D. Miller moved to pass SCR 1631 as amended. Seconded by Representative Lane. Motion carried.

The chairman asked for discussion on HCR_5057.

Representative Blumenthal moved to table HCR 5057. Representative Ramirez seconded the motion. Motion lost 11-9. Representative Bowden moved to pass HCR 5057 favorably. Seconded by Representative Harder. Following a period of discussion the motion carried 11-10.

The minutes for March 12 and March 13 were approved by the committee.

The chairman gave an update on School Finance being considered in the Senate Education Committee after which the meeting was adjourned by the chairman at 4:52 p.m.

Testimony presented before the House Committee on Education by Gerald W. Henderson, Executive Director United School Administrators of Kansas

March 26, 1990

Mister Chairman and members of the committee, I am Gerry Henderson representing United School Administrators of Kansas. We are in full support of the provisions of SCR 1631. All too often service to children is hindered by the lack of communication between schools and other agencies designed to help children and families. If it is not known at the present time which laws and/or regulations might unduly hinder service to children in need, then the study called for by the resolution is in order. If it is discovered, however, that other studies have identified the culprits, then steps need to be taken to resolve the problems rather than study them further.

I am frequently made aware of circumstances which serve to frustrate school people trying to provide educational and other services for kids. Just this past week I was made aware of a situation wherein a young man under SRS jurisdiction was reprimanded for refusing to subject himself to medical tests being administered by a school nurse because he had just the previous week had the same tests done as a part of SRS processing procedures. That young man did not need the hassles of bureaucracy added to his already troubled life. Surely records of this type can be made available to all agencies involved.

We would urge the committee to recommend SCR 1631 favorably for passage.

Mr. Chairman and members of the Committee, we appreciate the opportunity to appear before you on behalf of the 302 member boards of education of the Kansas Association of School Boards with regards to SCR 1631.

The Kansas Association of School Boards is pleased to add its support to the premise as set forth in SCR 1631. As we understand the resolution, the legislative coordinating council would appoint a special committee whose purpose would be to study how the mission and role of school districts are impacted by the work of various community-based agencies that provide social services for children.

We believe this type of study is needed to determine what possibilities exist for closer working relationships between non-educational agencies serving children and school districts. And, when the committee study is completed, we believe the committee could possibly provide recommendations to the legislature for removal of some of the barriers that now stand in the way of meaningful working relationships between school districts and other child centered social agencies.

Attachment 2. House Education 2-26-90 At the present time, these barriers cause duplication of effort, noncommunications of pertinent information between agencies and, in some cases, a fear that discussion between personnel from different agencies may be less than legal. These barriers, whether real or imaginary, are in place in many instances as a result of each agency trying to protect confidential information pertaining to juveniles.

It is also KASB's belief that the information and recommendation developed by such a committee could possibly have some effect on the implementation of HB 2218, the parents as teachers bill which has been signed into law.

KASB appreciates the opportunity to provide testimony in support of SCR 1631 and recommends that it be reported out of committee favorably.

AS A TEACHER, I SEE SOME OF THE PROBLEMS WITH OUR PRESENT SINGLE DIPLOMA SYSTEM THAT WE HAVE HERE IN KANSAS. TWO STUDENTS COULD MEET THE NECESSARY GRADUATION REQUIREMENTS NOW, ESPECIALLY IN LARGER SCHOOL SYSTEMS, AND HAVE TAKEN QUITE DIFFERENT COURSES. I ALSO HAVE THE
