Representative Shallenburger made a motion that an amendment be added that would limit political parties to a \$1,500 contribution annually.

An objection was made regarding the minutes of the February 15th meeting as to who seconded approval of the minutes. Recommends that House Bill No. 2725

Be amended:

On page 2, in line 41, by striking all after "state"; by striking all of line 42; in line 43, by striking all preceding "or";

On page 3, in line 18, by striking all after "state"; by striking all of line 19; in line 20, by striking all preceding "or":

On page 10, by striking all of lines 41 to 43, inclusive;
On page 11, by striking all of lines 1 to 13, inclusive; in
line 14, by renumbering section 13 as section 12;

On page 12, in line 12, by renumbering section 14 as section 13; in line 26, by renumbering section 15 as section 14; in line 34, preceding the period by inserting "if such committee is a state committee and with the county election officer if such committee is a local political committee"; following line 39, by inserting a new section to read as follows:

"Sec. 15. K.S.A. 25-904 is hereby amended to read as follows: 25-904. It shall be the duty of every candidate for nomination or for election to any city, unified school district, community junior college, township or county office, within thirty-(30) 30 days after each primary, general or special election, to file with the county election officer an itemized statement under oath of all expenditures made by such candidate or obligations contracted or incurred by him-or-her such candidate in connection with each primary, general or special election. If no expenditures are made and no obligations are contracted or incurred by a candidate, the candidate shall file with the county election officer a statement to that effect. No

candidate which is subject to the provisions of the campaign finance act (K.S.A. 25-4142 et seq., and amendments thereto) shall be required to file any report required by this section.";

Also on page 12, in line 40, after "K.S.A." by inserting "25-904,"; in line 41, by striking "25-4159,";

In the title, in line 10, by striking "amending the campaign finance act; amending K.S.A." and inserting in lieu thereof "relating to elections; concerning campaign finance; amending K.S.A. 25-904,"; in line 12, by striking "25-4159,";

And the bill be passed as amended.
