Representative Shallenburger offered an amendment that a system approved by the Secretary of State's office must be used if a county election clerk elects to not number ballots. This was seconded by Representative Sawyer and the motion to amend carried.

Following discussion Representative Lucas made a motion to pass SB 565 out of committee favorably, as amended. This was seconded by Representative Sawyer and the motion carried.

HB 2374, concerning school district mail ballot elections, was re-referred to the Election Committee. Representative Baker made a motion that we pass HB 2374 out of committee favorably, seconded by Representative Empson and the motion carried.

The Chair made an announcement that the Election Committee would meet in Room 123-S on Tuesday, March 20th as our regular meeting room was not available.

The minutes of the meeting on March 13th were presented for approval Representative Blumenthal made a motion to accept the minutes as written, seconded by Representative Johnson and the motion carried.
