Staff gave a review of <u>HB 2430</u> and stated it has statewide implication, cities were removed and changed protest petition from 60 days to 45. The motion failed.

Chairman Miller turned the Committee's attention to $\underline{\mbox{HB 2983}}$. A motion was made by Representative Patrick and seconded by Representative Lane that HB 2983 be passed favorably and placed on the consent calendar. The motion carried.

Chairman Miller stated that an Attorney General's opinion has been requested for $\underline{\text{HB }2943}$.

Chairman Miller turned the Committee's attention to <u>HB 2894</u>. A motion was made by Representative Patrick to table HB 2894; seconded by Representative Johnson. The motion carried.

Chairman Miller turned the Committee's attention to HB 3044. A motion was made by Representative Patrick to amend HB 3044 that the report would be published upon the filing of a complaint or charge; seconded by Representative Johnson. Motion carried. Chairman Miller called for any other discussion or amendments. A motion was made by Representative Patrick that if after two years following the suspected homicide certain relatives could request copies of the coroners report; those relatives within the first degree of consanguinity; seconded by Representative Lane. Motion carried.
