Representative Freeman testified in support of $\underline{\text{HB 292l}}$, stating that if nothing is done to help the fraternal benefit societies this session, many of them will go out of business - these people can't wait another year.

Representative Wisdom testified in support of <u>HB 2921</u>, stating that these organizations have a real problem and legislation is needed to help them.

Representative Turnbaugh testified in support of $\underline{\text{HB 2921}}$, stating that it seems a shame that many fraternal benefit society organizations will no longer be in existance unless steps are taken to remove them from the tax rolls. (Attachment 1)

Lucky DeFries, Topeka attorney, testified in support of $\underline{\text{HB }2921}$, stating that many fraternal organizations are feeling a financial pinch and that waiting until next year to provide relief will be too late for them.

Robert Duskie, Knights of Columbus, testified in support of <u>HB 2921</u>, stating that hardly a week goes by without him receiving a letter or phone call from one of his Councils in distress over the tax burden being applied to them. (<u>Attachment 2</u>)

Albert Arnold, Masonic Lodge, testified in support of \underline{HB} 2921, stating that they support many worthwhile causes financially, but now find themselves locked in a life and death struggle. (Attachment 3)

Tom Zarda testified for Tom Dechant, Knights of Columbus, in support of $\underline{\text{HB }2921}$, stating that if their councils are forced to close or sell their buildings due to high property taxes, there will be much good left undone in their communities. (Attachment 4)

Bob Runnels, Kansas Catholic Conference, testified in support of $\underline{\text{HB 2921}}$, stating that any recognition which eliminates the tax burden on these organizations will certainly release those dollars to charitable works in their communities. (Attachment 5)

Joe Berger, Kansas Sunflower Club Association, testified in support of $\underline{\text{HB 2921}}$, stating that if his organizations are tax exempt, then they will have more money available for charitable community services, and everyone will benefit. (Attachment 6)

Leonard Elrod, Ben Hur Masonic Lodge, testified in support of $\underline{\text{HB 2921}}$, stating that giving them a complete tax exemption from real estate and personal property taxes will help them to be in a good position to continue their charity programs and their youth programs. ($\underline{\text{Attachment 7}}$)

Merlin Grundy, Ben Hur Masonic Lodge, testified in support of <u>HB 2921</u>, stating that his lodge in Kansas City, Kansas, will have a deficit of \$2,575 this year if no further relief is granted. He also stated that a survey now in progess indicated that more than half of the states have laws that totally exempt fraternal organizations from real estate and personal property taxes. (Attachment 8)

Keith Farrar, BOTA, stated that he was not testifying as a proponent or an opponent, but is frustrated to sign an exemption for organizations that he knows are making a profit, and then has to deny exemptions for groups like those who testified today. He requested the committee to not only look at 501 (c) (8), but to look seriously at (c) (10).

Vice Chairman Marvin Smith concluded the hearing on HB 2921.

Mr. Chairman and Members of the Committee:

I come before you today to speak in favor of House Bill 2921, which would exempt certain property relating to fraternal benefit societies - orders or associations.

I am a member of Ben Hur Masonic Lodge #322 A.F. & A.M. located in Kansas City, Kansas. Ben Hur Masonic Lodge will be celebrating their 100th anniversary on April 26, 1990. Ben Hur Masonic Lodge has been at its present location for the past 68 years. The lodge is located in an older section of town. Even if they wanted to sell their property, there is no way that they could sell it for what it is appraised.

When our pioneer fathers came to Kansas over 100 years ago, they brought with them their lodges. Down through the years lodges of Kansas have played a vital part in the lives of thousands of men. George Washington, the father of our country and our first president, was a Mason, as have been many of our presidents.

These lodges survive solely on dues from their members. They are not for profit organizations. To tax them at commercial rate is grossly unfair. Even taxing them at the lower rate was an extreme hardship. They should not be classified any different than churches.

Ben Hur Lodge has paid their taxes, but at the rate they are going, they, as well as countless other lodges in the State of Kansas, will be closing their doors in 1991. It seems a shame that many of these fraternal benefit society organizations will no longer be in existance unless we take steps to remove these organizations from the tax rolls.

They are a part of our heritage. Are we going to allow their demise? I urge you to vote favorably on HB 2921.

Thank you Mr. Chairman and ladies and gentlemen of the Committee. May I first introduce myself and in so doing define my position. I am Albert O. Arnold Jr. Grand Secretary of Ancient Free and Accepted Masons of Kansas Please don't allow the title of Grand be misleading. Perhaps it would be better to say state Secretary of Masons In Kansas.

May I briefly explain our fraternity. We are the oldest known fraternity in the World. This naturally makes us the oldest in Kansas. We were organized as a jurisdiction of Masons on March 17th, 1856. Kansas was then a territory and was not admitted into the Union until January 29, 1961.

Who are we? We are men of a Deity faith. Further, I might tell you we are not and exclusive white Protestant, Anglo American organization. Although we so not enumerate our membership as to races, national origins or religious faith, we do know we have some of each major race in the world. This would also include many Deity faiths in our ranks.

As Masons we are connected or appended to several other Orders. First we are Blue Lodge members. Then we have the York Rite, Scottish Rite and the Shrine. Additionally we have the Order of Eastern Star, the Rainbow for Girls, Job's daughters and Order of DeMolay for Boys. Each of these orders are in turn involved with a Charitable endeavor.

In 1892, we established a Home for our aged in Wichita. This is on going. We have already contirbuted \$160,00 this year and expect more. Through our Kansas Masonic Foundation we are supportin Oncology research. For the ninth consecutive year we have donated \$100,000 or more to this effort. WE have an annual essay contest in support of education. Our efforts as Shriners are perhaps better know to you. This in support of our orthopedic and burns hospitals. A Knights Templars we contribute of eye treatment for the indigent. This September we will be announcing the opening of a new clinic to treat speech disorders. This will be in conjunction with Children's Mercy Hospital of Kansas City. We have already invested \$47,000 in this effort and expect it to cost much more. There are others to be sure. Nationally we can authenticate \$850,000 spent each and every day.

My purpose is not to enumerate our Charities in their entirety, for we rarely every offer such information. But, we find ourselves locke in a life and death struggle. We have surved our constituent Lodge and now refer you to the attached.

Actually a number of our lodges rent or lease from other organizations and individuals, so the figures given are really inclusive of these numbers.

The bill under consideration states 501 (c) 8 only. But, we and I feel sure there are other orders operating under 501 (c) 10. We respectfully request to be included in your consideration for exemption.

REMARKS PREPARED FOR PRESENTATION TO THE KANSAS HOUSE OF REPRESENTATIVES COMMITTEE ON TAXATION ON THE FIFTEENTH DAY OF MARCH 1990

I am here today to speak on behalf of HOUSE BILL NO. 2921. I represent the Knights of Columbus in Kansas, and am their elected State Deputy (President). We have 30,000 dues-paying members in Kansas organized into 211 local councils (units), and are located in every County in Kansas. Together with our wives and family members we comprise a voting bloc of 120,000 Kansans.

BACKGROUND

The Knights of Columbus is a fraternal benefit society organized for the betterment of manking. Each of our councils conduct programs which benefit the Community, the Family, Youth, and Church. Last year our 30,000 members raised over \$850,000 for charity and, even more impressive, volunteered 331,000 hours of service to the community and to disadvantaged, retarded, and sick citizens of Kansas.

Each of our 211 councils is exempt from federal income taxation pursuant to section 501(c)(3) of the internal revenue code of 1986. Thirty-two of our councils own buildings, usually incorporated for liability reasons, which are exempt from federal income taxation pursuant to section 501(c)(8) of the internal revenue code. The State Board of Tax Appeals has ruled that under current Kansas law our council buildings are subject to property taxation since they are organized under section 501(c)(8) rather than section 501(c)(3).

Our 32 councils which own buildings are faced with a 1990 property tax bill of \$128,942, which will force many of them to close!

REASONS TO SUPPORT HOUSE BILL #2921

- 1. As aforementioned, the Knights of Columbus do much to support the less fortunate of our State. In fact, the 32 councils which own buildings donated \$147,737 for charity last year and volunteered 50,039 man-hours of service to the community. If these councils are forced to close, or sell their building due to high property taxes, there will be much good for the community that is left undone. Clearly, those councils which own their own building will suffer a loss of members and thereby will face a reduced, volunteer work-force to serve the needs of Kansans.
- Our council homes are currently used by many community groups free of charge. Organizations such as the Boy Scouts, Girl Scouts, 4-H, church guilds, Chamber of Commerce, Lions Clubs, and other fraternal groups use the local K of C hall as their meeting place without paying any rent. Breakfasts, community soup suppers, bingos for charity are conducted in the K of C building. If forced to sell the building to a for-profit group could the community be assured of the rent-free status? Probably not. Where would these groups turn to find a facility for their own charitable endeavors?
- 3. There is precedent for the exemption of K of C buildings.

 Other groups, such as the V.F.W. and the American Legion, are exempt from property taxation. Their purpose is manifestly the same as the Knights of Columbus. To provide for the betterment of their members and the community at large.

- 4. Knights of Columbus are not in competition with forprofit businesses. Again we have 32 council homes. Of these:

 9 have a Class A liquor license; 9 have a Class B liquor
 license, and 14 have no liquor license at all. Those with
 a license are not perceived as a threat to public establishments
 since they are usually open only for the convenience of their
 members.
- 5. Our council homes are located in some small, rural communities throughout Kansas. Here, they represent the only community meeting place. To close them down due to excessive property taxes would deprive the town of its only meeting place.
- used for the charitable endeavors of the local council. They do not inure to the benefit of any individual or individuals. Rather, they augment the charitable works of the local unit. Without these revenues the council would not be able to provide the support for the disadvantaged citizens that they currently do. Without the support of the Knights of Columbus our sick, retarded, young people, and communities would suffer.

SUMMARY

For all of the reasons enumerated I urge your support of HOUSE BILL #2921. Kansans will benefit by its passage. Thank you.

This is the situation of our lodge and at the present rate we will de-

plete our small savings account in another year.

We give a \$100.00 scholarship to a sudent for college every year.

Also as the report above shows we contribute over \$2,000.00 a year to
our Masonic Home at Wichita.

At the present rate of taxes on our property, we will have enough money to make it through the year of 1991, at that time our funds will be completely depleted, when this happens it will mean a building will be left empty, it will not be saleable for the simple fact that the taxes are so high on it that no one will buy it and it will become an eyesore to the neighborhood. Or until someone will buy it at a tax sale.

This means we stand a good chance of losing a number of members of the Masonic organization, this in turn will mean less support to our Masonic Home in Wichita for the aged. If you multiply this by a hundred lodges or more, we stand a chance of losing our Masonic Home in Wichita, and this means that the residents of the home will have to go somewhere. Which means that other agencies would have to pick up some of the expenses.

Among other things that would be lost is the small scholarship that we give to senior students each year. We also support a local student to play in the all masonic band each year, for the Shrine East West Football game. Which I am sure most of you know that this game goes to support the Crippled Childrens Hospitals.

We also help to support the Oncology Dept. at K.U. Medical Center in Kansas City, Kansas.

Gentleman this is only a partial list of the things we do and support with the money which we take in.

And we feel that by giving us a complete tax exemption from Real Estate Property tax and personal property tax we will be in a good position to continue our charity programs and give help to our youth programs.
