MINUTES OF THE Senate COMMITTEE ON Agriculture

The meeting was called to order by <u>Senator Jim Allen</u> Chairperson

__a.m./\f.\f. on __January 30 ___, 1990in room423-S____ of the Capitol.

Conferees appearing before the committee: Larry D. Woodson, Director, Division of Inspection, Kansas Board of Agriculture Nancy Kantola, Committee of Kansas Farm Organizations

Senator Allen called the Committee to order and called on staff for a review of SB 419, SB 420, and SB 421.

Staff explained that the three bills update the dairy laws of Kansas and that the changes are not policy changes. The proposed changes include some new definitions and eliminate some words/terms no longer used. The Milk Advisory Committee would be given authority to make recommendations on any legislation pertaining to the dairy industry. The elimination of the butterfat tax with restructuring of fees with some increases are proposed. The penalty for noncompliance is proposed to be changed from a Class C to an Unclassified Misdemeanor with a fine not to exceed \$500.

The Chairman called on Mr. Woodson to testify.

Mr. Woodson gave the Committee copies of his testimony (attachment 1) and expressed support for the three bills. Mr. Woodson explained that two changes were suggested; the changes would be to not eliminate the words 'light cream' from line 37 on page one of SB 419 and on page 7, line 32 of SB 419 the word 'dairy' should be changed to the word 'milk'.

In answer to Committee questions, Mr. Woodson answered that there are now 1,106 Grade A Milk producers and 330 manufactured milk producers in the state and this is down some 250 producers over the last few years. Mr. Woodson answered that at present the dairy industry pays about 45% of their laboratory costs and that the proposed changes would have the industry paying about 49%. Mr. Woodson answered that an agreement had been made with the dairy industry regarding laboratory testing; with this agreement the Board of Agriculture cannot alone decide to require that industry do more testing than they are now doing but neither can they alone take away from the industry the amount of testing they are now doing.

The Chairman called on Ms. Kantola to testify.

Ms. Kantola provided copies of her testimony for the Committee (attachment 2) and expressed support and requested that SB 419, SB 420, and SB 421 be recommended favorable for passage.

The Chairman called for action on Committee minutes.

Senator Daniels made a motion that the Committee minutes of January 25 be approved; Senator Sallee seconded the motion.

The Chairman adjourned the Committee at 10:43 a.m.

Mr. Chairperson, Members of the Senate Agriculture Committee, I am Larry D. Woodson, Director, Division of Inspections, Kansas State Board of Agriculture and I am here in support of Senate Bills 419, 420, 421.

The three bills under consideration have been under active consideration for over two years and have been the subject of numerous staff meetings, dairy advisory meetings, hearings held during legislative session plus interim study hearings.

The objectives were to update the respective laws; increase the fees on the manufacturing grade milk produced and processed; update and adjust license fees (including the license for homemade ice cream manufactures) elimination of the butterfat tax; restate authority for regulations on equipment; and provide for uniform and effective enforcement through suspension orders, stop sale provisions and civil penalties.

We believe the three bills allow us to accomplish our objectives.

With reference to the manufacturing grade fees and the restructuring of the licenses, an additional \$74,000 of revenue is being realized. I have attached a quick reference chart of the proposed license and fee schedules.

Based on this schedule plus existing revenues, the composition of the dairy budget is estimated to be 50.4% fee supported and 49.6% general fund revenue supported.

Final pen and ink changes include the following:

SB 419 page 1 line 37 Light Cream should not be crossed out.

Senate agriculture Committee 1-30-90 attachment 1 Page 7, line 32 the word dairy should be replaced with the word milk. There is no definition in the Grade A Law for dairy products. They are referred to as milk products.

This concludes my testimony however, we will attempt to answer any questions that the committee may have.
