Nancy Lindberg, on behalf of the Attorney General and Consumer Protection Advisory Council, appeared before the committee to request a bill called "credit card privacy". The intent of the bill would be to prohibit merchants from recording consumers telephone numbers on charge slips when using credit cards for making a purchase. It would be a follow-up to legislation passed last session which prohibits recording credit card numbers on checks. She further stated it was felt this is personal information that is not needed and is not necessary.

Representative Flower moved to introduce this bill request. It was seconded by Representative Crumbaker and the motion carried.

Chairman Hamm informed the committee of a request from Steffen's Dairy, Wichita, which would make it legal for Kansas companies to offer premiums on milk cartons as out-of-state companies are allowed to do.

Representative Freeman made a motion to introduce a bill making this correction. Representative Correll seconded the motion. Motion carried.

Representative Correll asked the committee if they had any objections to possibly having a "Pecan Day" in the Agriculture Committee with information being brought regarding production of pecans in Kansas. There were no objections from the committee.

Representative Mollenkamp made a motion to approve the minutes of February 5, 6 and 7, 1991. Representative Rock seconded the motion. The motion carried.

The committee adjourned at 9:15 a.m. The next meeting of the House Agriculture Committee is scheduled for Wednesday, February 20, 1991, at 9:00 a.m. in room 423-S, State Capitol.
