The House Elections Committee was called to order by Chairman Tom Sawyer at 9:10 a.m. on February 5th, 1991 in Room 521-S.

The minutes of the meeting on January 31st were presented for approval.

Representative McKechnie made a motion to approve the minutes, seconded by Representative Macy and the motion carried.

The Chair opened hearings on  $\overline{\text{HB}}$  2079 and called on Ron Thornburgh from the Office of the Secretary of State.  $\overline{\text{HB}}$  2079 prohibits inserting any campaign literature in any absentee ballot envelopes and prescribing penalties for this violation. He proposed making an amendment which would state "no person shall, while delivering an absentee ballot, also deliver or present any political campaign literature or advertising designed to influence a voter for or against a particular candidate or question submitted". (Attachment 1) The committee discussed this at length regarding whether the worker or the candidate would be responsible, delivering the ballot at one time and then immediately delivering the literature, if the mail man would be exempt, penalty imposed, etc. Arden Ensley stated a Class C misdemeanor was punishable with a fine not to exceed \$500 and not to exceed one month in the county jail. Representative Wells would like some clarification of a ballot being in a drop box versus the ballot being in the possession of the Election officer. She also stated some of her constituents did not feel the instructions were clear. Ron and Arden Ensley, Revisor, will look at this to see if the language is now clear or if there should be some clean up. Following this discussion hearings were closed on HB 2079.

Chairman Sawyer called for final action on <u>HB 2068</u>, concerning the minimum votes required for nomination in a primary election. Ron Thornburgh provided the committee with a chart showing the percentage of votes needed, county by county, if figured at 5%. (Attachment 2). After committee discussion, Representative Shallenburger made a motion to amend HB 2068 to read 5% instead of 10% of registered voters required by a write-in candidate in the primary election to gain access to the general election. This was seconded by Representative Thompson and the motion to amend carried. Representative Baker made a motion to pass HB 2068 favorably, as amended, seconded by Representative Macy and the motion carried.

The Chair next called for final action on <u>HB 2069</u>. Arden Ensley stated this bill needed some clean up, eliminating in lines 17, 18 and 19 reference to precincts and also in line 25 changing "him" to a generic term. Representative McKechnie made a motion to amend HB 2069 as recommended, seconded by Representative Jones and the motion carried. Representative McKechnie made a motion to pass HB 2069 favorably, as amended, seconded by Representative Thompson and the motion carried.

The Chair made two announcements:


- 1) anyone having bill requests should let him know and they would be heard at the next committee meeting

## STATE OF KANSAS

TESTIMONY OF RON THORNBURGH HOUSE ELECTION COMMITTEE FEBRUARY 5, 1991

House Bill 2079

Thank you Mr. Chairman and members of the committee for the opportunity to appear before you today on behalf of Secretary of State Graves.

House Bill 2079 prohibits the enclosure of any campaign material in an absentee ballot envelope. We experienced a problem last year when a candidate for office requested absentee ballots on behalf of voters and then stuffed the envelope with campaign material. We feel this is very much like campaigning at the polling place, which is prohibited.

Because the language of the bill only prohibits the enclosure of campaign material in the ballot envelopes, we also offer the following amendment:

"No person shall, while delivering an absentee ballot, also deliver, present or provide any political campaign literature or advertising designed to influence a voter to vote for or against a particular candidate or question submitted."

This language will prohibit any campaign material from reaching an absentee voter in conjunction with their absentee ballot.

In conclusion, we ask that you report House Bill 2079 favorable for action as amended.
