Chairman Blumenthal called meeting to order when quorum was present.

DISCUSSION AND ACTION ON SUB SB 237

Rep. Ramirez gave a briefing on the subcommittee's study. Their recommendation is to concur with the Senate--lift the sunset and keep the Dealers Review Board in an advisory capacity under the Department of Revenue. The Board will be reviewed for sunset, as part of the Dept. of Revenue, in 1995. Motion was made by Rep. Ramirez to report Sub SB 237 favorably, seconded by Rep. Bowden, motion carried.

DISCUSSION AND ACTION ON SB 306

Rep. Hamilton reported on the inquiries she made regarding adding extra persons to the ASTRA Board. She indicated that all her contacts had no objection to adding a Chief of Police and Sheriff to the Board, but felt that any additional members from the Office of Emergency Preparedness was both unnecessary and burdensome.

Rep. Hamilton also felt that the wording in this bill, which goes back to 1968, should be up-dated. Motion was made by Rep. Hamilton to amend lines 16, 26, 33 and 1 on page 2--delete civil defense and insert Kansas Law Enforcement Telecommunication Network or Committee where appropriate. Motion seconded by Rep. Weimer, motion carried. On bill as a whole, motion by Rep. Hamilton to report SB 306 favorably as amended, seconded by Rep. Lawrence, motion carried.

DISCUSSION AND ACTION ON HB 2448

Staff distributed copies of proposed amendment to HB 2448 prepared by Revisor's office, (Attachment 1). The proposed amendment calls for reducing 15-day notice to 10 days and to include notice for temporary rules and regulations with a 5-day notice. Rep. Hamilton gave a briefing to the committee. Motion was made by Rep. Hamilton to approve amendment as indicated on the sheet. Motion seconded by Rep. Benlon, discussion followed, motion carried.

Rep. Ramirez moved to pass out HB 2448 adversely, no second to the motion, motion failed. Following discussion, motion to pass HB 2448 favorably as amended was made by Rep. Hamilton, seconded by Rep. Bishop, motion carried.

Chair recognized Rep. Brown who announced that the compromise bill being drafted to supersede  ${\tt HB~2514}$  is not ready. NO ACTION TAKEN ON  ${\tt HB~2514}$ .

Motion to approve minutes for March 27th was made by Rep. Benlon, seconded by Rep. Bowden, motion carried.
