Representative Snowbarger made a motion to reconsider the four bills. Representative Garner seconded the motion. The motion carried.

Representative Garner made a motion to refer the four bills favorably.

A committee member noted one of the four bills required amendment; that it would be preferable to consider them one by one.

The motion died for lack of a second.

The Chairman called for action on HB 2470.

Representative Sebelius made a motion to amend HB 2470 in accordance with Mr. Bob Coldsnow's balloon bill.

Revisor's staff explained provisions of the balloon bill.

Representative Everhart seconded the motion to amend. The motion carried.

Representative Garner made a motion to pass HB 2470 favorably as amended. Representative Gomez seconded the motion. The motion carried.

Representative Sebelius made a motion to pass HB 2425 as amended. Representative Everhart seconded the motion. The motion carried.
