Rep. Jack Sluiter moved to amend in Section 14. to conceptually provide that the notice shall be either posted or in writing. Rep. George Gomez seconded the motion. Motion carried.

Chairman Hensley announced that Jim Wilson, committee revisor, would draft a "balloon version" of the amendments to <u>House Bill No. 2076</u> for committee members to review and take final action on in tomorrow's meeting, April 2, 1991.
