A RESOLUTION adopting rules of the House of Representatives for the 1991-1992 biennium, relating to contests of elections of members to the House of Representatives.

Be it resolved by the House of Representatives of the State That the following rules shall be adopted for the of Kansas: 1991-1992 biennium.

ARTICLE 50. CONTESTS OF ELECTIONS OF MEMBERS

Rule 5001. Reports of Select Committees on Contests of Elections of members of the House; consideration and action by House. (a) Reports of Select Committees on Contests of Elections of members of the House of Representatives submitted pursuant to K.S.A. 25-1451 shall be set for a special order of business in accordance with Rule 4302.

- (b) At the time set by the House, the report of the select committee shall be presented by the Chairperson of the select committee to the full membership of the House for consideration and debate. The Chairperson shall review and present the report in full. At the conclusion of such presentation, the presiding officer shall announce that consideration, debate and action upon the recommendations of the select committee are in order. Each proposition on which the report of the select committee has made independent findings and recommendations shall be considered and an independent determination made by the membership of the House of Representatives. The rules of the House governing procedure in the Committee of the Whole shall govern the consideration and debate of the report of the select committee.
- (c) At the conclusion of consideration and debate of reports of select committees on the contest of elections of members of the House of Representatives, the membership of the House shall

HOUSE RESOLUTION NO. ______

By Committee on Rules and Journal

A RESOLUTION adopting rules of the House of Representatives for the 1991-1992 biennium, relating to contests of elections of members to the House of Representatives.

Be it resolved by the House of Representatives of the State of Kansas: That the following rules shall be adopted for the 1991-1992 biennium.

ARTICLE 50. CONTESTS OF ELECTIONS OF MEMBERS

Rule 5001. Reports of Select Committees on Contests of Elections of members of the House; consideration and action by House. (a) Reports of Select Committees on Contests of Elections of members of the House of Representatives submitted pursuant to K.S.A. 25-1451 shall be set for a special order of business in accordance with Rule 4302.

- (b) (1) At the time set by the House, the report of the select committee shall be presented and reviewed by the Chairperson of the select committee to the full membership of the House. The rules of the House governing procedure in the Committee of the Whole shall govern the consideration and debate of the report of the select committee.
- (2) At the conclusion of the presentation of the report of the select committee, the House shall debate and determine what action should be taken with regard to the two ballots upon which the select committee was unable to reach agreement and make recommendations, but unopened ballots shall remain unopened in accordance with paragraph (5).
- (3) After determination of the action to be taken with regard to ballots upon which the select committee made no recommendations, consideration, debate and action shall be taken upon the report and recommendations of the select committee as a

fules + Journal (attachment #3) 1-31-91 whole and no action shall be taken upon any individual recommendation of the select committee prior to the taking of action upon the report as a whole.

- (4) If the report and recommendations of the select committee fails to receive the approval of, or is rejected by, a majority of the members of the House of Representatives voting thereon, consideration, debate and action may be taken individually upon each issue included in the report and recommendations of the select committee.
- (5) Ballots which have remained unopened by the district court shall remain unopened by the House of Representatives unless it is determined that the outcome of the election is dependent thereon.
- (c) At the conclusion of consideration and action upon the report of the select committee, the membership of the House shall determine and declare the name of the member duly elected to membership in the House of Representatives. A call of the House may be ordered upon the taking of a vote upon the declaration of membership in the House of Representatives.
