The meeting began with the request for the intoduction of two bills by Senator Doyen. The first one would strike the prohibition of using trust money for economical development. (Attachment 1). The other bill regards small county museums. It would exempt small cities from putting in sprinkler systems in these small museums which are often open during the summer only with a limited number of visitors at any one time.

Sen. Daniels made a motion for the introduction of both bills, Sen. Lee seconded, and the motion carried.

 $\underline{\mathtt{SB}}$ 142 - An act directing the Secretary of State to convey certain land to the City of Ogden, Kansas.

Joe de la Torre of the Secretary of State's office testified briefly in support of $\underline{SB\ 142}$. He stated that Secretary Graves has reviewed the property subject to this bill and thinks it is appropriate for the City of Ogden to own this land. It would cause no fiscal impact.

The Chairman asked Mr. de la Torre to submit written testimony. Also, he asked if there was any history of how the land became owned by the state. John Cowan, a cartographer, explained that it was due to a drastic change in the river bed due to flooding in 1951. He displayed maps of the area to indicate what land is involved and to aide in answering questions the committee might have.

Senator Lana Oleen testified in support of the bill. (Attachment 2). It was determined for Sen. Steineger that the bill involves ten to twelve acres of land.

Representative Glasscock gave further testimony in support of <u>SB 142</u>. (Attachment 3). In response to questions from Sen. Allen regarding the original ownership of the land involved, Sen. Oleen responded that it is a river channel change created by the flood of 1951 leaving the land, reverting by statute, as property of the State of Kansas.

Gail Hoke, Mayor of the City of Ogden, testified in support of the bill. (Attachment 4). With regard to the ownership of the land involved in the bill, Mr. Hoke said that the land was originally owned by the City of Ogden. The flood of 1951 changed the river channel and left a dry river bed. This land

includes platted streets of the original City of Ogden. He emphasized that the City of Ogden would not be gaining title to anyone's property; it is state owned property. Also, Mr. Hoke informed the committee of an auction of private property where the county sold property within the high bank area which is owned by the state. Sen. Oleen added that this bill merely takes care of conveyance of this abandoned river channel owned by the state to the City of Ogden.

Wilton Thomas, Riley County Commissioner, testified in support of the bill. Attachment 5).

Sen. Gaines had further questions about the original ownership of the land involved. Sen. Oleen responded that the bill does not address any property that is titled, only land which is owned by the state because of the high water to high water mark.

Kenneth Romanski of the City of Ogden stood to state that there is a belief on the part of abstractors that the state has the road right of way on this property. There are five platted streets on this state land located between city owned property. This land could be used by the City of Ogden for street access to a ball diamond area.

Sen. Steineger made a motion to recommend SB 142 favorable for passage, Sen. Daniels seconded, and the motion carried.

The minutes of February 14 were approved.

Copies of requested written testimony by George Boyd on $\underline{SB\ 116}$ which had been previously heard had been distributed to the committee. (Attachment 6).

The meeting was adjourned at 9:35 a.m.

PROPOSED BILL NO. _____

AN ACT concerning certain trusts; relating pledging of other money for trust purposes; amending K.S.A. 58-2433 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 58-2433 is hereby amended to read as follows: 58-2433. Funds received by the beneficiary under the provisions of any trust created under the provisions of this act shall be kept and maintained in a special account or accounts and used only for the purpose of such trust and no funds of said the beneficiary derived from any source whatsoever other than the trust property, or the operation thereof, shall be charged with, or expended for the execution of said the trust, except-by express-action-of unless approved by the legislative authority of the beneficiary first-had-and-no-funds-derived-from-the--levy--of ad-valorem-taxes-shall-be-used-for-or-pledged-for-the-purposes-or execution -- of -- such-trust. The officers or any other governmental agencies or authorities having the custody, management or control of any property, real or personal, or both, of the beneficiary of such trust, or of such a proposed trust, which property shall be needful for the execution of the trust purposes, hereby are authorized and empowered to lease such property for said such purposes, after the acceptance of the beneficial interest therein by the beneficiary as hereinafter provided, or conditioned upon such acceptance.

Sec. 2. K.S.A. 58-2433 is hereby repealed.

Sec. 3. This act shall take effect and be in force from and after its publication in the Kansas register.
