MINUTES OF THE SENATE COMMITTEE ON ASSESSMENT AND TAXATION

Chairman Dan Thiessen called the meeting to order at 11:10 a.m. and said the agenda today will be working on the funding for the Education Proposal that the Senate Education Committee has completed action on. He said, another purpose of the meeting is to see if any committee member needs additional information that Research may be working, for the committee, and he recognized Ben Barrett, Associate Director, Legislative Research Department.

Ben Barrett said the Senate Education Committee's proposal is a revision of the school district's equalization act, and that it replaces the different school finance approach that was included in the House Bill.

He said, the main changes in the bill are, the budget pupil control for the 1992-1993 school year which is, 100.5% to 100.3% so the increase per pupil is  $\frac{1}{2}\%-3\%$ .

He said, the 3 year merger at the 4th and 5th enrollment catagory is not affected by the committee changes, and that merger continues to stay on course. There is added to the proposal a minimum expenditure requirement, that no school district would be allowed to budget or spend less than 90% of the median budget per pupil of the districts enrollment catagory in the prior year. He said, the bill has a cap on high expenditure districts, and the districts who budgets per pupil exceed the median in its enrollment catagory for a prior year by more than 125%, would not be allowed any increase in its budget per pupil percentage of growth in the subsequent school year.

The income tax rebate of 24% at the present time is phased out so that the entire rebate in 1992-1993 would be 18%, the following year 12%, the next year 6% and in 1995-1996 would be gone, he said, the income tax rebate is tied to the taxable income component of district wealth, so the taxable component of district wealth is phased out on the same schedule that the income tax rebate is phased out so that by the 1995-1996 school year, the definition of district wealth will consist only of the assessed valuation of the district.

The income tax rebate would be made, an element of local effort under the proposal, and he said, it does not count as any part of the local effort at the present time, and the reason for the change. He said, the mineral production tax receipts that some school districts receive would, for the first time be equalized, and the would be counted as part of the districts local effort in computing its state aid money.

He said, added to the law would be a minimum 25 mill levy that all school districts would have to impose, and there is also a re-capture provision, meaning that, a school district, when taking into account its local effort, including its income tax rebate would not be required to levy as many as 25 mills to fully fund its budget, but would have to levy its 25 mills under this plan, and the difference between, what is produced by the 25 mills, might otherwise would be required to be levied under the budget, is remitted to the State and then is used to help fund a school finance program.

He said, the re-capture provision included in the plan, replaces a penalty provision that is in the law at the present time, for school districts to levy 3/5ths of the minimum general fund tax rate, may forfeit all or a portion of their various categorical aids, and he said, that provision is gone and replaced by this re-capture provision.

He said, the hold harmless provision under the current law which phases out in a 2 year period are eliminated as far as this plan, and school districts were authorized to levy 2 mills for technological education by the 1991 legislation, and a number of

districts took advantage of that tax levying authority, and under this plan the technology levy is equalized, and the amount that the school districts levied in 1991, would be added to the 1991-1992 base budget, so when the 1992-1993 budget controls are applied to school districts, that amount would be equalized as part of the base funding of the school districts.

He said, these are the distribution components of the changes adopted by the Senate Education Committee, and he said, the committee also added some reform elements which he said, the most significant is the one that increases the school term. He said, presently we have for grades one through eleven, a minimum school term of 180, 6 hour days, or 1080 hours, and under this plan, there would still be 180, but would be 6½ hour days, and the new minimum hours would be 1170, for grades one through 11.

He said, a special provision is applied to grade twelve, and kindergarten, now is 2½ hours for 180 days, is left unchanged. (**NO WRITTEN TESTIMONY**)

After committee discussion, Chairman Thiessen recognized Dale Dennis, Assistant Commissioner, KS State Board of Education.

Dale Dennis said attached to his hand-out is a computer print-out (L92C6) which makes an effort to show the effects of the school finance plan as approved by the Senate Education Committee. He said, the principal provisions of this plan are outlined, on the list page of his hand-out. (1)Budget Controls. (2)District wealth. (3)Income Tax Rebate. (4)Equalizes technology levy. (5)No hold harmless. (6)Minimum Levy.

Mr. Dennis, turned the committee members attention to page 2 of his hand-out and he reviewed and explained all the concepts from (1) through (6) of his hand-out. (**ATTACHMENT 1**)

After committee discussion and questions by the members to Mr. Dennis, and answered by Mr. Dennis, The Chairman thanked Ben Barrett, and Dale Dennis for explaining all the components by the Senate Education Committee.

Chairman Thiessen said the committee's time has ran out, and he said, the committee will meet again on adjournment of the Senate, and he adjourned the meeting at 12:12 p.m.

Attached is a computer printout (L92C6) which makes an effort to show the effects of the school finance plan as approved by the Senate Education Committee on Tuesday, March 31, 1992. The principal provisions of this plan are outlined below.

- \* Budget controls--.5% - 3.0% plus 5.9% for 4th enrollment category not to exceed median of 5th enrollment category. Provides a budget floor of 90% of prior year's median general fund budget per pupil for their enrollment category. In addition, no school district may raise their general fund budget per pupil if it is 125% above median for their enrollment category.
- \* District wealth--Assessed valuation and 18% taxable income
- \* Income Tax Rebate--18% (1992-93); 12% (1993-94); 6% (1994-95); zero thereafter
- \* Equalizes technology levy
- \* No hold harmless
- \* Minimum Levy--25 mills (If 25 mills overfunds the school district budget, the difference is sent to state)

This information is based upon the latest data available but should be considered an estimate and used cautiously.

NOTE: The mill levies computed in Column 18 assumes each unified school district will have the same cash balance on July 1, 1992, as they had the prior year.
