Sen. Reilly apologized for having to meet at a later time because the Senate being in session and announced the committee would conduct hearings on HB 2719, 2761 and 2762.

Sen. Vidricksen requested time to introduce a senatorial district reapportionment plan ($\underbrace{Attachment\ 1}$). $\underbrace{He\ made\ a\ motion\ the}$ committee recommend introducing it as a bill, and the motion was seconded by Sen. Morris. After discussion, the Chairman brought the question to a vote and was in doubt as to its passage, thus a The motion passed by a 3 to 2 vote. division was called.

Sen. Reilly introduced the following proponents to HB 2719:

No one appeared to oppose the bill. Sen. Reilly called attention to a letter from Chuck Magerl, President of the Free State Inc., requesting the ability to obtain a caterer Brewing Co., license for his microbrewery (Attachment 4). After discussion, it was Mr. Conant's opinion that an amendment would have to be made to make a caterer license obtainable for Mr. Magerl. Morris made a motion to adopt an amendment to HB 2719 to allow the Free State Brewing Co. the ability to obtain a caterer license. The motion was seconded by Sen. Vidricksen, and the motion passed. Sen. Strick made a motion that the committee adopt an amendment to allow retail liquor stores to remain open and Election. Days and it was seconded by Sen. Pand The motion open on Election Day, and it was seconded by Sen. Bond. passed.

McClure indicated she wanted to make a motion for an amendment which would enable the winery to develop a business in Mead with a jam/jelly manufacture. She stated she understood the winery could operate through one outlet only. After consulting with Mr. Fair, who indicated it was not economically feasible to do so, that the company would have to bring their products to his

winery site, Sen. McClure withdrew her motion.

Sen. Bond moved that HB 2719 be recommended favorably for passage as amended, and the motion was seconded by Sen. McClure. The motion passed. (Committee Report, Attachment 5)

AN ACT concerning state senatorial districts; providing for the reapportionment thereof; repealing K.S.A. 4-4,101 through 4-4,142.

Be it enacted by the Legislature of the State of Kansas:

Section 1. In accordance with section 2 of article 2 of the constitution of the state of Kansas, the state of Kansas is divided into 40 single member state senatorial districts. Such districts are reapportioned in accordance with section 1 of article 10 of the constitution of the state of Kansas.

- Sec. 2. (a) As used in this act, "voting district," "tract," "block group" or "block" means, respectively, a voting district (VTD), tract, block group or block identified on the official U.S. 1990 decennial census maps.
- (b) Voting districts, tracts, block groups and blocks are referred to in this act by the alphanumeric code by which they are identified on the official U.S. 1990 decennial census maps and data lists.
- (c) The boundaries of counties, voting districts, tracts, block groups and blocks referred to in this act are those boundaries as they exist and are identified on the official U.S. 1990 decennial census maps.
- Sec. 3. (a) If a county, voting district, tract, block group or block is not included within a senatorial district established by this act, such county, voting district, tract, block group or block shall be attached to the state senatorial district to which it is contiguous and, if contiguous to more than one state senatorial district, it shall be attached to the contiguous state senatorial district which has the least total population.
 - (b) If a county, voting district, tract, block group or block

is included in two or more state senatorial districts established by this act, such county, voting district, tract, block group or block shall be attached to and become a part of the state senatorial district which has the least total population.

"AN ACT concerning farm wineries; providing for winery outlet licenses; amending K.S.A. 1991 Supp. 41-308a and 41-310 and repealing the existing sections."

Be amended:

On page 3, after line 14, by inserting:

- "Sec. 2. K.S.A. 1991 Supp. 41-308b is hereby amended to read as follows: 41-308b. (a) A microbrewery license shall allow:
- (1) The manufacture of not less than 100 nor more than 5,000 barrels of domestic beer during the license year and the storage thereof;
- (2) the sale to beer distributors of beer manufactured by the licensee;
- (3) the sale, on the licensed premises in the original unopened container to consumers for consumption off the licensed premises, of beer manufactured by the licensee;
- (4) the serving on the premises of samples of beer manufactured by the licensee, if the premises are located in a county where the sale of alcoholic liquor is permitted by law in licensed drinking establishments; and
- (5) if the licensee is also licensed as a club or drinking establishment, the sale of domestic beer and other alcoholic liquor for consumption on the licensed premises as authorized by the club and drinking establishment act; and
- (6) if the licensee is also licensed as a caterer, the sale of domestic beer and other alcoholic liquor for consumption on unlicensed premises as authorized by the club and drinking establishment act.

(b) Not less than 50% of the products utilized in the manufacture of domestic beer by a microbrewery shall be grown in Kansas except when a greater proportion of products grown outside this state is authorized by the director based upon findings that such products are not available in this state. The label of each container of domestic beer shall clearly set forth the proportion of the products utilized in the manufacture of the beer which was from agricultural products grown in Kansas.

- (c) A microbrewery may sell domestic beer in the original unopened container to consumers for consumption off the licensed premises at any time between 6 a.m. and 12 midnight on any day except Sunday and between 12 noon and 6 p.m. on Sunday. If authorized by subsection (a), a microbrewery may serve samples of domestic beer and serve and sell domestic beer and other alcoholic liquor for consumption on the licensed premises at any time when a club or drinking establishment is authorized to serve and sell alcoholic liquor.
- (d) A microbrewery license shall apply only to the premises described in the application and in the license issued and only one location shall be described in the license.
 - (e) No microbrewery shall:
- (1) Employ any person under the age of 18 years in connection with the manufacture, sale or serving of any alcoholic liquor;
- (2) permit any employee of the licensee who is under the age of 21 years to work on the licensed premises at any time when not under the on-premise supervision of either the licensee or an employee of the licensee who is 21 years of age or over;
- (3) employ any person under 21 years of age in connection with mixing or dispensing alcoholic liquor; or
- (4) employ any person in connection with the manufacture or sale of alcoholic liquor if the person has been convicted of a felony.
- (f) Whenever a microbrewery licensee is convicted of a violation of the Kansas liquor control act, the director may

revoke the licensee's license and all fees paid for the license in accordance with the Kansas administrative procedure act.";

TESTIMONY REGARDING HOUSE BILL 2761 SENATE FEDERAL AND STATE AFFAIRS COMMITTEE

REPRESENTATIVES

House Bill 2761, as amended by the House Committee of the Whole, would provide mandatory, random, auditing of funeral pre-need accounts by the Secretary of States Office. The figure of 25 was proposed by that office as the number of firms they felt they could audit each year WITHOUT any additional staff, thus adding a minimum of cost. - Also, the \$100 per day fee is consistent with the amount present allotted to the Secretary of States Office for the auditing of cemetery accounts.

I feel this bill in its present form (with any technical amendments as proposed by staff) is acceptable to the concerned parties, and should provide some excellent help in the regulation of preneed financed accounts.

HOUSE BILL 2762

This bill provides for two alternative methods of helping to be sure preneed monies are placed in the financial institution. A firm may either have the check made out directly to the financial institution and be sure it is deposited within 7 days...or the firm can maintain \$100,000 in 'dishonest employee insurance' and can then have 30 days in which to deposit the monies. This bill is acceptable to the Board of Mortuary Arts, as well as the Kansas Funeral Profession and third party sellers, and is a compromise between those groups in order to provide a better control over preneed funds.

Once again this bill was introduced by the House Public Health and Welfare Committee at the request of the Kansas State Board of Mortuary Arts. The current wording of the bill represents a compromise between the Kansas Cemetery Association, the Kansas Funeral Director's Association and the Mortuary Arts Board. Once again it is the intention of the Mortuary Arts Board to tighten the belt in the area of consumer regulation of pre-financed funeral agreements.

This bill would give some definition to what happens to pre-financed monies prior to their deposit in the appropriate financial institution. It specifies the manner in which payment is to occur, and there is a defined time-frame of deposit.
