Chairperson Fuller opened discussion on <u>HB 2020</u>, an act concerning community strategic planning grants, amounts and uses.

Representative Wempe made a motion to reinstate the first phrase of line 1, page 2 "not more than one planning grant be awarded" but delete the words "one action grant". This was seconded by Representative Henry. The motion carried.

Representative Wempe made a motion that lines 36-41, page 1 be changed to state that the sum of an action grant awarded not exceed the cap contained in the bill. This was seconded by Representative Rutledge. Following discussion Representative Wempe withdrew his motion.

Representative Wempe made a substitute motion that lines 36-41, page 1 be changed to state "action grants shall not exceed \$25,000 for any single county total....... and no action grant totals exceed \$65,000", seconded by Representative Rutledge and the motion carried.

Representative Bishop made a motion to add to new section (c) "prior to September 1 of each year the Kansas department of commerce and housing shall present a status report of activities including but not limited to specific community strengths and weaknesses and planning issues and strategies"...., seconded by Representative Sader and the motion carried.

Representative Rutledge made a conceptional motion to reinstate old section (c) with the exception of lines 14 and 15 and add "all regents universities and community colleges", seconded by Representative Vickrey. Following discussion Representative Rutledge withdrew his motion.

Representative Bishop moved to pass HB 2020, as amended, favorably, seconded by Representative Mason and the motion carried.

The Chair adjourned the meeting at 4:30 p.m
