Bill Morrissey, Associate Director, Division of Workers Compensation, distributed information on the number of awards and appeals in the Division of Workers Compensation from FY89 through the first six months of FY93. The number of preliminary orders is also shown from FY89 through FY92. (Attachment 1)

Jerry Ann Donaldson presented a video by the National Council of State Legislators that gave a brief synopsis of the problems that experts across the country see in workers compensation. In many areas across the country workers compensation has changed from a labor management problem to an economic development problem. Workers compensation was intended to be a quick and easy way to pay fair benefits promptly to injured workers; however, the system has broken down. Workers compensation claims in 1972 totaled \$5.8 billion, today it is estimated at \$80 billion.

The National Council of State Legislatures Blue Ribbon Panel on Workers Compensation, chaired by Senator Alicia Salisbury of Kansas, selected five topics for review: administration, insurance economics, permanent partial disability, delivery of medical services, and safety and health policy. This report is scheduled to be discussed by the committee Thursday, February 4, 1993. Copies of the video are available from NCSL.
