Chairperson Flower called the meeting to order, drawing attention to Hearings scheduled on HB2218 and HB2372.

Chair requested a staff briefing on HB2218.

Mr. Furse gave a comprehensive explanation of HB2218. This language relates to the education requirements concerning dentists. He drew attention to changes proposed in the Dental Practices Act, i.e., part of the exclusions of that particular Act.

### CHAIR OPENED HEARINGS ON HB2218.

Representative Glasscock offered a hand out (Attachment No. 1). He expressed his personal thanks to the Chair for scheduling hearings on HB2218. He stated HB2218 is designed to allow Kansas the opportunity to attract world class dental clinicians to continuing education courses in the state. Currently, it is a criminal offense for a dentist licensed in another jurisdiction to participate in "hands on" continuing dental education courses in Kansas under the supervision of a nationally or internationally recognized clinician. This causes difficulty in attracting highly regarded clinicians. HB2218 is meant to eliminate these sanctions and to allow for licensed dentists from other states to participate in Kansas based courses. He urged support.

Representative Glasscock answered questions, i.e., there is a clinic in Manhattan, Kansas that could provide this type of training; a dentist licensed in another jurisdiction can take the course, but currently, it is illegal to perform "hands on" care.

For the record: (Attachment No.2) was provided by Senator Oleen. (written testimony only)

Dr. David Sager, licensed dentist, offered a hand out (Attachment No.3). He stated the Midwestern Institute for Advanced Dental Studies is certified by the Kansas Dental Board and regulatory agencies in other states to provide continuing education. The Institute is a non-profit organization. It was noted, there are no dental schools in Kansas. Most continuing dental education is obtained by slideshow, and the Midwestern Institute for Advanced Dental Studies consider this "education" an inadequate way to teach new dental procedures. He detailed how current practices must be carried out since a licensed dentist cannot participate if he is licensed in another jurisdiction. HB2218 would change the law and allow this to be reversed. By allowing this to occur, superior dental education for Kansas dentists will include "hands on" training and Kansas consumers will benefit. Currently, it is difficult to attract top flight training programs in Kansas because of the legal implications. This proposed legislation will improve the availability of continuing education for Kansas dentists. The Midwestern Institute supports protecting the health of consumers and the best way to do that is to allow superior education. He urged support.

Dr. Sager then drew attention to materials in his hand out, a booklet indicated as Attachment No.3 contains a summary of the different steps HB2218 proposes; a summary sheet; comments from noted educators from around the country; comments and testimony from other dentists.

Scott Hesse, Attorney for the Midwest Institute, and a consumer of dental services, offered hand out (Attachment No.4). He noted he became involved in "hands on" dental education issue when dentist acquaintances were trying to get a world renowned German dentist to lead a "hands on" dental clinic in Manhattan. Had Dr. Axel Kirsch come to Kansas at that time (3 years ago), he would have been guilty of a misdemeanor. Mr. Hess stated, he was solicited to try and offer help for this situation. He views current policy related to this subject as not very good public policy. With the help of the Kansas Dental Board, they worked cooperatively for a way that Dr. Kirsch and any other clinician licensed in another state or country could demonstrate innovative dental practices. He detailed the progression of steps taken to continue working on this problem. He noted participatory or "hands on" dental education is far superior than being lectured to. If HB2218 is passed, Kansas could become a Mecca for training clinic and could become a leader in the field for continuing education for dentists. He urged favorable consideration.

Carol Macdonald, Administrative Secretary of Kansas Dental Board, (Attachment No. 5), made a brief statement, noting the Board takes no formal position on HB2218. The Board will not oppose this legislation if it can be determined the State of Kansas would not incur liability if this legislation is enacted.

David Hanzlick, Assistant Executive Director of Kansas Dental Association offered hand out (Attachment No.6), and noted he is the only conferee today for the Dental Association since inclement weather has prevented Dr. Jim Muller and Dr. Tom Wilson from attending and giving testimony in person. He stated, the concept in HB2218 is very different from current law as it would permit out-of-state and foreign dentists to perform procedures on patients while participating as students at a continuing education program, while not being licensed in Kansas. This is a concept the Kansas Dental Association cannot support. In reviewing this proposed concept, the Kansas Dental Association has check statutes of other states and find no state that permits what HB2218 would allow. Most states have provisions very similar to Kansas current law.

Mr. Hanzlick drew attention to the written testimony from Dr. Muller, (see Attachment No.7). Dr. Muller writes, the practice of dentistry by licensed dentists from other states and countries within Kansas should be strictly regulated to safeguard patients, ensure that patients are not placed at unnecessary risk, or provided with substandard care. Teaching of "hands on" care should be limited to approved courses sponsored by major teaching centers have a peer review process, a human use committee, both to ensure that patients receive appropriate care. He wrote he opposes changes proposed in HB2218.

Numerous questions were asked by members, i.e., some thought perhaps a short term license could be granted visiting dentists teaching these new techniques. It was noted Ohio does grant temporary licensure for this type situation. There was discussion in regard to whether or not there is concern regarding after-care for patients only treated by out of state or foreign dentists and not those treated by Kansas dentists. It was noted there are only three states not having a dental school and Kansas is one of those three. Dr. Sager stated, he is Kansas born, and licensed to practice dentistry in both Kansas and Nebraska, and it is sad that he cannot bring quality people in for quality education programs in the state of Kansas. He can offer this in the facility at Crayton University in Omaha, Nebraska, and as a Kansan, would like to have the opportunity to offer the same type of excellent educational opportunities in Kansas. It was determined, the medical profession can offer training by out of state licensed physicians, since the medical school is a "safe haven" and allows for these procedures.

CHAIR CLOSED HEARINGS ON HB2218.

Chair stated Committee is open for action on bills previously heard.

Chair drew attention to HB2196, licensure of psychologists.

Rep. Rutledge moved to report HB2196 adversely, seconded by Rep. Morrison. No discussion. Vote taken. Motion carried.

Chair drew attention to HB2343.

Chair requested Ms. Correll to make comments on materials that had been requested by members. Ms. Correll had responded to those requests and provided material and noted it had been delivered to each members office this morning. (This material is in the form of a memorandum from Ms. Correll.) Ms. Correll answered questions, i.e., if HB2343 is adopted in the present form, the requirements for licensure of social workers employed by the SRS, positions that would be more than social workers, i.e., social worker 1,2,3,4,5,6, any person who is engaged in an activity that would follow the scope of practice of social work would not be required to be licensed, but could work as an employee of SRS carrying out responsibilities that might follow in part or total under the definition of social work without having to meet licensure requirements.

Members asked numerous questions regarding this issue. It is the view of some members, if this legislation is passed, it will declassify social work for social work positions, primarily for the Department of SRS. It was suggested a classification other than social worker, be assigned.

Rep. Rutledge moved to report HB2343 adversely, seconded by Rep. Morrison. No discussion. Vote taken. Motion carried.

Chair called attention to HB2372.

CHAIR OPENED HEARINGS ON HB 2372.

Rep. Helgeson offered hand out (Attachment No. 8). He gave a brief explanation of HB2372, i.e., if a consumer has filled out the back of their drivers license, that they request their organs to be donated, it is then the responsibility of the hospital to follow that directive given by the consumer, or be at risk for losing their license. He stated HB 2372 has merit, but he honestly believes this issue needs to be studied further. He recommends this issue, and other legislation, i.e., HB2490, HB2475, HB2170, HB2250, could perhaps be recommended to the Joint Committee on Health Care Decisions for the 1990s. This review should include a thorough review of all ethical questions related to the issue at hand. He answered questions.

Ingo Angermeier, Vice President, St. Francis Hospital, and State Council of the American Red Cross, offered hand out (Attachment No. 9). He stated, he appears today in behalf of the Kansas Hospital Association in the effort involved in the belief in the organ donations program, i.e., public awareness regarding organ and tissue donations and the need for efficient procedures to make sure donors' wishes are followed. He stated, the motivation behind HB2372 is commendable, however, there are concerns with language. i.e., the penalty is too severe as it would allow the Department to suspend or revoke a hospital's license for failure to comply with provisions of an anatomical gift. Secondly, HB2372 does not take into account there may some valid reasons to refuse the provisions of an anatomical gift, i.e., medical reasons, or family members not wishing to make the gift even though it was the wish of the donor. He noted perhaps this legislation could be further studied along with similar legislation currently in the Judiciary Committee

Greg Reser, Medical Facilities Certification Administrator, Hospital and Medical Programs, Department of Health and Environment offered hand out (Attachment No. 10). He noted failure to comply with the donor's request for organ or tissue donations, gives authority to the Department to suspend a Hospital license. He noted this is a severe penalty. There are only four reasons that the Department can currently suspend a license. He listed those reasons. He stated along with his work in the Department with the donor programs, he has a very personal interest with the programs, and is sensitive to this subject, since his son has recently celebrated his 8th anniversary with a donor heart. He agrees with Rep. Helgersen this issue could perhaps be further studied. He stated, there are times when family members disagree with the donor's request, therefore the severity of the language regarding license suspension in HB2372 is confusing when noting the Act itself allows the "donee may accept or reject the gift". He stated concerns, i.e., the expertise of the Department of Health and Environment to investigate potential complaints related to the issues of K.S.A. 65-3210 through 65-3217 is questionable; the practicality of denying a facilities license for failure to comply with an anatomical gift act. The Department recommends the importance of organ donor awareness, the importance of hospitals enacting organ donor protocols. He indicated HB2372 as written, is flawed, and it is recommended by the Department of Health and Environment this legislation should not be acted upon until these flaws are addressed.

Numerous questions were asked by members, i.e., every small hospital is not equipped to handle this program; actually, most hospitals cannot support organ transfers; procedures of obtaining organs and transportation of those organs was explained. It was pointed out the most common resistance to organ or tissue donation comes from the family of the donor.

CHAIR CLOSED HEARINGS ON HB2372.

Chair adjourned the meeting at 3:05 p.m.

The next meeting is scheduled for March 8, 1993.

TESTIMONY - HB 2218  
 PUBLIC HEALTH AND WELFARE COMMITTEE

Thank you Madame Chair and members of the committee for the opportunity to appear before you today in support of HB 2218. I know that yours has been a busy committee and with only two days left before the "house of origin" deadline, I'm sure you are rushed to complete the committee's agenda. Madame Chair, thank you for agreeing to hear this bill - I genuinely appreciate it.

HB 2218 is, at its core, a bill designed to allow Kansas the opportunity to attract world class dental clinicians to continuing education courses in our state.

Under current law, it is a criminal offense for a dentist licensed in another jurisdiction to participate in "hands on" continuing dental education courses in Kansas under the supervision of a nationally or internationally recognized clinician.

This makes it difficult to attract these highly regarded clinicians to participate in continuing education courses and subjects Kansas dentists to professional sanctions should they assist in seminars attended by dentists from other jurisdictions.

HB 2218 is meant to eliminate these sanctions and to allow licensed dentists from other states to participate in Kansas based courses. These would occur in an office environment similar to a dental school experience under the supervision of a qualified clinician.

Madame Chair, I would be happy to stand for questions, but there are other conferees who wish to speak and in whose testimony many of your questions may be answered.

PROPOSED AMENDMENT TO K.S.A. 65-1423

The Kansas Dental Practices Act would be amended to:

- # attract world class dental clinicians to continuing dental education courses in Kansas;
- # allow dentists licensed in states and countries other than Kansas to participate in "hands on" continuing dental education in Kansas;
- # allow licensed dentists to participate in continuing dental education courses;
- # continue to protect Kansas citizens from unlicensed dental practitioners;
- # promote the latest dental techniques to Kansas dentists;
- # make Kansas a leader in continuing dental education;
- # promote economic development in Kansas through increasing the number of dental seminars in the state;
- # allow dentists to study in an office environment similar to the dental school experience; and
- # improve oral health care for Kansas citizens.

The current Kansas Dental Practices Act:

- # makes it a criminal offense for a dentist licensed in another jurisdiction to participate in "hands on" continuing dental education courses in Kansas under the supervision of a world class clinician;
- # makes it difficult for Kansas dentists to attract world class clinicians to participate in continuing dental education courses; and
- # subjects Kansas dentists to sanctions by the Kansas Dental Board if the Kansas dentist participates in a seminar with a dentist from another jurisdiction.

The proposed amendment to K.S.A. 65-1423 has previously been introduced in the Kansas legislature during the 1992 session. After significant revision to the initial bill that was drafted, the bill passed the Senate. The revised bill addressed concerns the Kansas Dental Board initially had with it. The bill died in committee in the House of Representatives after little consideration. The bill that passed the Senate has been reintroduced in the House of Representatives in substantially the same form as last session.

The proposed amendment to K.S.A. 65-1423 is supported by the Midwestern Institute for Advanced Dental Studies, an organization of dentists involved in providing world class continuing dental education in Kansas. The Kansas Dental Board, the dental profession's regulatory body, has previously announced support for the concept of "hands on" or participatory continuing dental education. The proposed amendment has been opposed by some dentists and special interests. The proposed amendment to K.S.A. 65-1423 has received support from leading individual dental practitioners around the state, country and world.

TESTIMONY OF DR. R. DAVID SAGER

I am Dr. David Sager, a licensed Kansas dentist, and I come before the Committee seeking approval of House Bill 2218. I am the President of the Midwestern Institute for Advanced Dental Studies, Inc., a non-profit organization dedicated to providing participatory, or "hands on", continuing education for dentists in Kansas and throughout the Midwest Region. The Midwestern Institute for Advanced Dental Studies is certified by the Kansas Dental Board and regulatory agencies in other states to provide continuing education. The Midwestern Institute has also been recognized as a dental organization approved by the Kansas Dental Board pursuant to K.S.A. 65-1423(d).

Currently, dentists are trained at dental schools and then allowed to operate on patients. There are no dental schools in Kansas. Practicing dentists are required by some states, including Kansas, to obtain continuing dental education to maintain their licenses. Most continuing dental education is obtained by slideshow in dark hotel meeting rooms and even on cruise ships. Dentists belonging to the Midwestern Institute for Advanced Dental Studies consider this "education" inadequate to teach the new techniques required to serve the needs of Kansans.

Institute dentists believe that "hands on" dental training is the best way to learn the latest dental techniques. "Hands on" training allows the dentist to touch the patient. "Hands on" training is the type of training that students receive in dental schools every day, but is rarely available after graduation day.

Under current Kansas law, dentists licensed in another state are unable to come to Manhattan to receive "hands on" dental training from another dentist. Even a world renowned licensed dentist would have to just watch the proceedings. If the dentist touches the patient receiving care, that dentist would violate Kansas law. If convicted, the dentist licensed in another state could be sentenced to one year in jail and fined \$1,000.

House Bill 2218 would allow a dentist licensed in another jurisdiction to come to Kansas to receive "hands on" dental training under the supervision of a clinician or a Kansas dentist. The bill gives the Kansas Dental Board guidelines to follow in regulating "hands on" continuing dental education. The bill allows the Kansas Dental Board to enact rules and regulations designed to protect the patients, the student-dentist and the clinician. The bill is adequately balanced to protect the dental clinician, the dental student and the dental patient. When House Bill 2218 is passed, Kansas will be a leader in offering the best continuing dental education experiences in the world.

House Bill 2218 is intended to provide Kansas dentists with the ability to receive superior "hands on" dental training. By allowing dentists licensed in other states to participate in educational seminars, different medical opinions will be shared. Currently, it is difficult to attract top flight training programs to Kansas because of the legal consequences to out of state dentists and the relatively small number of Kansas dentists available for these programs in the state. By allowing superior dental education to Kansas dentists, Kansas consumers will benefit from dentists' superior knowledge.

House Bill 2218 is legislation that will improve the educational possibilities available to Kansas dentists, which will translate to superior dental service to consumers. House Bill 2218 will not allow the wholesale importation of unlicensed dentists to practice dentistry in the state. House Bill 2218 is a measured law which will allow Kansas dentists access to superior dental education while allowing adequate supervision by the Kansas Dental Board through its existing powers and rule and regulatory authority conferred upon the Kansas Dental Board. The Midwestern Institute is for protecting the health of consumers and the best way to protect patients' health is to allow superior education. If the legislature does not pass House Bill 2218, dentists will continue to receive dental education in hotel conference rooms with clinicians showing slides to participants, much to the horror of the country as portrayed on 60 Minutes about two years ago. The dentists will not have the benefit of "hands on" training on the most current dental techniques.

House Bill 2218 will benefit dentists and, most importantly, patients and we strongly support the passage of this legislation.

TESTIMONY OF DR. TIMOTHY MCVANEY

I am Dr. Timothy McVaneY. I am a dentist licensed in Nebraska, Iowa, Colorado and Kansas. I have completed specialty training for the practice of periodontal dentistry. I am the Treasurer of the Midwestern Institute for Advanced Dental Studies and the Director-designate of Continuing Education for the Creighton University School of Dentistry in Omaha, Nebraska. I teach Periodontics and Geriatric Dentistry at Creighton University Dental School two-half days per week and maintain a private dental practice four days per week. I am before you to advocate the passage of Senate Bill 603 which is a bill intended to increase the dental education potential in the Midwest and which will benefit Kansas dentists and patients.

Although I am a licensed Kansas dentist, my primary practice is in Omaha, Nebraska. I believe that "hands on" continuing dental education is vastly superior to receiving education by lecture alone. Because of this philosophy, I have expended significant time and money in obtaining a Kansas dental license so that I could participate in "hands on" dental education in Kansas. Although obtaining a Kansas dental license has been a significant burden, it was worth the expense. These costs were not small and the vast majority of dentists will not seek licensure in another state in order to receive periodic continuing dental education offerings.

I support Senate Bill 603 because it will allow dentists to come to Kansas and receive a quality "hands on" continuing dental education. This will be beneficial to Kansas dentists and their patients for numerous reasons. The foremost reason is that top flight clinicians can be attracted to Kansas to

demonstrate the most advanced dental techniques. To be able to attract these clinicians it must be possible to have a sufficient number of dentists interested in any particular dental procedure. Kansas and Nebraska do not have a large number of practicing dentists and it is difficult to obtain the full spectrum of continuing dental education at home, although Kansas and Nebraska residents have a full spectrum of dental problems and their dentists must have adequate education to address those needs. By allowing licensed dentists from other jurisdictions to participate in such seminars there would be a sufficient number of dentists available to underwrite these educational offerings. Kansas dentists and patients will further benefit from the interaction of medical and dental opinions and ideas from other dentists in their region. Medical and dental education should have no state borders.

Senate Bill 603 allows for adequate supervision of dentists by the Kansas Dental Board. The bill provides the Kansas Dental Board with guidelines to follow in regulating "hands on" continuing dental education. The bill allows the Dental Board to enact rules and regulations designed to protect the patients, the dental practitioner - student, and the clinician. The bill is adequately balanced to protect all participants.

The bill before the committee will not allow unlicensed dentists to set up a dental practice without obtaining a Kansas license. The bill specifically provides for continuing dental education opportunities. Unamended portions of the Kansas Dental Practices Act should protect Kansas citizens from unlicensed dentists.

The Kansas Dental Board had some concerns regarding issues brought up by

Senate Bill 603. The members of the Midwestern Institute for Advanced Dental Studies have worked closely with the Kansas Dental Board to resolve those differences. The Institute's primary concern is improving oral health care and the well being of its members' patients. The Kansas Dental Board has proposed changing some of the language of Senate Bill 603. The Institute supports the changes proposed by the dental board.

Senate Bill 603 will enhance educational opportunities for Kansas dentists. These improved educational opportunities will allow dental practitioners more experience in the clinical delivery of oral health care. It will improve their ability to learn of new techniques and how to use new devices to deliver improved oral health care for their patients. It is our belief that this added clinical experience improves the quality of care delivered by dentists. Patients will benefit from these improved services through the delivery of a higher quality of oral health care. It is our hope that this bill will allow educational opportunities that will assist dental practitioners to provide improved oral health care for the citizens of Kansas and the Midwest.

I have been so impressed with this approach that I developed this hands-on approach for an implant course at Creighton. I arranged to send the participants from this course at Creighton to Dr. Kirsch's presentations in Manhattan at Midwest Institute meetings. This approach with direct instructor participation in oral health care delivery is unique to continuing education but it is not unique in this country. As an educational institution, we have begun to develop this 'hands-on' concept for other continuing education courses. Our first group has completed the Implant Fellowship. This first group even included a dentist from Denver, Colorado, who had flown in with a patient from his practice so that he could learn the implant procedures.

I believe that it is important for the state of Kansas to allow graduates of accredited dental schools licensed in other states to be allowed to participate in courses that provide actual patient care while training as a dentist under the supervision of a qualified instructor. Kansas has no dental school, but there are two institutions in Kansas which allow the practice of dentistry by non-licensed persons under the supervision of an instructor - The Wichita State University and Johnson County Community College, both of which have dental hygiene programs. I am not aware of any problems with these programs and believe they are an advantage to consumers and through the years have caused no harm. I have served for twelve years as an examiner for the Central Regional Dental testing Service, Inc. This testing service has provided the entrance level minimal competency examination for all dentists and hygienists seeking licensure in Kansas. Most of these candidates for licensure practice on patients without holding a license. They take the licensure examination without even the aid and supervision of an instructor. This is not an unusual activity as currently eleven states accept the results of this testing agency for use in licensing. There are also other Regional testing agencies that examine non-licensed dentists using live patients. This practice has gone on for years and I am not aware of any problems associated with it. I hope that H.B. 2218 can be acted on favorably.

## Participation courses for all dentists? Only if law changes

Last year a bill was introduced to the Kansas Senate (Senate Bill No. 603). The Bill was to amend K.S.A. 65-1423 to allow dentists not licensed in Kansas to take participation (hands-on) courses conducted in the State of Kansas. As continuing education chairman of the Kansas Academy I see the importance of participation courses and believe it is a concept that should be endorsed by the Kansas Academy. To receive your Masters in the Academy you are required to complete participation courses. I acquired many of my hours in states in which I held no license. Certain conditions need to be applied. What I would like to see is the allowance for a dentist to participate in hands-on courses in Kansas without a Kansas license provided that the dentist:

1. Is attending scientific meetings of the Kansas Dental Association or any of its components or other like dental organizations which have been approved by the Kansas Dental Board;
2. Is practicing under the supervision of a clinician approved by the Kansas Dental Board;
3. Is attending a continuing education course approved by the Kansas Dental Board (all Academy courses are approved by the Board);

4. Is currently licensed to practice dentistry in another state or country;

5. Is in good standing with the dental regulatory authority in the state or country of the dentist's licensing;

6. Limits the number of days the dentist would be allowed to practice in Kansas to the length of the participation course;

7. Allows for follow-up on treated patients;

8. Provides liability coverage consistent with the procedure being performed by the student.

One of the best ways to learn is by hands-on (actual patient) treatment. It has proven to be safe and effective. It is important for the state of Kansas to allow graduates of dental schools licensed in other states and countries to be allowed to participate in courses that provide actual patient care while training as a dentist under the supervision of a qualified instructor. I am not aware of any problems with these programs and

believe they are an advantage to consumers and through the years have caused no harm.

The Central Regional Dental testing Service, Inc. has provided the entrance level minimal competency examination for all dentists and hygienists seeking licensure in Kansas for over twenty years. Most of these candidates for licensure practice on patients without holding a license. They take the licensure examination without even the aid and supervision of an instructor. This is not an unusual activity as currently eleven states accept the results of this testing agency for use in licensing.

There are also other Regional testing agencies that examine non-licensed dentists using live patients. This practice has gone on for years and I am not aware of any problems associated with it. If we can accept non-licensed persons to practice without the direct supervision of a clinician why can't we allow licensed individuals (albeit licensed in other jurisdictions) to practice under the direct supervision of a clinician in Kansas? This type of legislation would be a giant step forward for Kansas.

## Region XII keeps Kansas and adds two more states

Kansas will get to remain a part of Region XII and Alabama and Mississippi will be added to the Region in a restructuring of the Academy Regions. The restructuring was necessary to accommodate New Jersey who wanted their own region. Because of the large size of Region V, honoring their request seemed wise.

Under the original recommendation by the Council on Constitution and Bylaws, Kansas would have become a part of Region X which includes the states to our north. Kansas did not want to leave Region XII and Region X really didn't want to adopt us.

Much lobbying was done and after hours of politicking and trading off,

Kansas was allowed to stay in Region XII.

Kansas was an original member of Region XII and has always been an integral part of the decision making process in the Region. Another reason cited for keeping us in the Region was the close relationships formed and the cooperation between the states.

With the addition of Alabama and Mississippi, Region XII will have over 1500 members, four more delegates and more strength in the AGD.

The actual conversion to the new region format will not begin until after next summer's AGD meeting in San Diego. The region, however, will be busy until then writing a new regional constitution and by-laws.

The Regional meeting Feb. 12 and 13 in Oklahoma City will include representatives from Alabama and Mississippi. It is hoped that there will be a large group from Kansas able to make the meeting.

Frequently dentists from out of state are not licensed in the state of Kansas although they hold a current license in the state in which they practice. In fact I am a member of three study clubs that have members from other states and that involve practicing dentistry on live patients:

I would be more than happy to supply you with the rosters of each of these organizations if you thought they might be of value to you.



I returned Sunday from a hands-on (participation) course sponsored by the Midwestern Institute for advanced Dental Studies Inc. in Manhattan, Kansas. The course was about the use of lasers in dentistry and was taught by Dr. Chuck Arcoria, Associate Professor of Operative Dentistry, Baylor College of dentistry.

Last year a bill was introduced to the Kansas Senate (Senate Bill No. 603). It passed in the Senate but failed in the House. A similar Bill will be introduced in the coming legislative year. The Bill was to amend K.S.A. 65-1423 to allow dentists not licensed in Kansas to take participation (hands-on) courses conducted in the State of Kansas. I don't know the exact form in which the Bill will be introduced but I support the concept and I hope the Kansas Dental Association and the Kansas Dental Board will support it also (with certain conditions that I hope will be acceptable to all). What I would like to see is the allowance for a dentist to participate in hands-on courses in Kansas without a Kansas license provided that the dentist:

1. Is attending scientific meetings of the Kansas Dental Association or any of its components or other like dental organizations which have been approved by the Kansas Dental Board;
2. Is practicing under the supervision of a clinician approved by the Kansas Dental Board;
3. Is attending a continuing education course approved by the Kansas Dental Board;
4. Is currently licensed to practice dentistry in another state or country;
5. Is in good standing with the dental regulatory authority in the state or country of the dentist's licensing;
6. Limits the number of days the dentist would be allowed to practice in Kansas to the length of the participation course;
7. Allows for follow-up on treated patients.

One of the best ways to learn is by hands-on (actual patient) treatment. I have experienced hands-on education both in Kansas and in other states. It has proven to be safe and effective. I believe that it is important for the state of Kansas to allow graduates of dental schools

licensed in other states and countries to be allowed to participate in courses that provide actual patient care while training as a dentist under the supervision of a qualified instructor. There are two institutions in Kansas which allow the practice of dentistry by non-licensed persons under the supervision of an instructor - The Wichita State University and Johnson County Community College, both of which have dental hygiene programs. I am not aware of any problems with these programs and believe they are an advantage to consumers and through the years have caused no harm. I have served for twelve years as an examiner for the Central Regional Dental testing Service, Inc. This testing service has provided the entrance level minimal competency examination for all dentists and hygienists seeking licensure in Kansas. Most of these candidates for licensure practice on patients without holding a license. They take the licensure examination without even the aid and supervision of an instructor. This is not an unusual activity as currently eleven states accept the results of this testing agency for use in licensing. There are also other Regional testing agencies that examine non-licensed dentists using live patients. This practice has gone on for years and I am not aware of any problems associated with it. If we can accept non-licensed persons to practice without the direct supervision of a clinician why can't we allow licensed individuals (albeit licensed in other jurisdictions) to practice under the direct supervision of a clinician in Kansas? This type of legislation would be a giant step forward for Kansas.

This letter is written in response to Senate Bill 603, which I strongly support and hope for its passage into law. Recently, I presented a hands-on continuing education course in dentistry for the Midwestern Institute for Advanced Dental Studies. I was greatly dismayed because of the inability of non-Kansas residents to participate in the course involving patient treatment. In essence, their role was relegated to bystanders in a non-contributory manner. The nature of this course requires a clinical hands-on approach in order to completely benefit from the educational experience. Indeed, it was a pity that competent practitioners from other, adjacent jurisdictions could not be given the opportunity to fully learn new techniques and apply them in their dental practices. The individuals who attended this course should be commended for their willingness to expand their horizons and offer a higher degree of care to their patients, even though the potential for learning could not be completely fulfilled.

It is my belief that the State of Kansas can significantly benefit from the passage of this bill because of the enhanced aspirations for patient treatment that these non-Kansas residents possess. Wouldn't it be advantageous for the image of the State of Kansas to have non-resident professionals leave with a positive experience, eager to have other individuals return because of the outstanding training? I am thankful of the efforts of those enlightened legislators, like yourself, who can rise above the discord and petty disagreement to help the community at-large by enhancing the quality of oral health care.

TESTIMONY OF WM. SCOTT HESSE

May it please the committee, I am Scott Hesse and I come before the legislature as a proponent of House Bill 2218. I come before the committee as a citizen of Kansas who is a consumer of dental services. For the sake of clarity, I would also tell the committee that I am the attorney for the Midwestern Institute for Advanced Dental Studies. I became involved with the Institute about three years ago because I believe in the concept of participatory, or "hands on", continuing dental education. I believe that House Bill 2218 will help educate the dentists of Kansas which, in turn, will lead to improved dental care for persons like you and me.

I became involved in "hands on" dental education three years ago when a number of my dentist acquaintances were trying to get a world renowned German dentist to come to Kansas to lead a "hands on" dental clinic in Manhattan. If Dr. Axel Kirsch would have come to Kansas at that time and participated in "hands on" dental training, he would have been guilty of a misdemeanor and could have been sentenced to jail. At that time I was an attorney for the Kansas Corporation Commission and had previously been an Assistant Attorney General. One of the agencies I had been assigned to as an Assistant Attorney General was the Kansas Dental Board so I was somewhat familiar with its laws. Individual dentists approached me to see if I could help them in their crusade for better continuing dental education and I readily agreed. It seemed to me that it was not good public policy for Kansas to keep a world renowned, licensed German dentist from showing Kansas dentists important dental techniques. I approached the Kansas Dental Board and suggested a way in which Dr. Kirsch could

demonstrate his techniques in Kansas and obey Kansas law. Through the tremendous cooperation of the Kansas Dental Board, we arrived at a way that Dr. Kirsch, and any other clinician licensed in another state or country, could demonstrate innovative dental practices in Kansas and obey the law. From these efforts the Midwestern Institute for Advanced Dental Studies was born.

The next logical step is to allow dentists that are licensed in other states or countries to participate in "hands on" continuing dental education in Kansas under the supervision of a clinician. This would be training similar to what unlicensed dental students receive in dental school. House Bill 2218 would allow for that. Currently, a licensed Nebraska dentist could not be a part of participatory dental training taking place in Kansas. If he were, he would be guilty of a misdemeanor and could spend time in a Kansas jail. If House Bill 2218 is passed, Kansas would become a Mecca for dental training. Dentists from all over the world could come to Kansas, trade ideas and participate in continuing dental education. The interchange of ideas and techniques will make better educated Kansas dentists. Better educated Kansas dentists will be more able to serve Kansas dental patients.

I have testified before the Kansas Dental Board in the past on behalf of "hands on" continuing dental training. The Kansas Dental Board has approved the concept. House Bill 2218 passed the Kansas Senate last year in its current form. The bill was written in such a manner as to ease any fears that the Dental Board may have had in allowing licensed dentists from another state to participate in "hands on" dental training in Kansas. The Kansas

Dental Board has stated that it does not want to subject the State of Kansas to any liability by the passage of a law similar to House Bill 2218. My opinion is that under the Kansas Tort Claims Act, specifically K.S.A. 76-6104(a), the State of Kansas would be immune from liability if this bill is passed. The bill gives the Kansas Dental Board significant regulatory authority over such training sessions. The bill has been written to protect the citizens of Kansas, and other states, from being victimized by untrained, unlicensed dentists. Only dentists licensed in other states and countries will be allowed to participate in "hands on" training in Kansas. Dental special interests should not be worried that out of state dentists will come to Kansas and take away business because the bill is written so Kansas dental business interests will be protected. I do know that the hotel and restaurant industry in Manhattan is grateful to have the Spring and Fall meetings of the Midwestern Institute for Advanced Dental Studies because it brings approximately thirty dentists to town for quality education.

The public policy of the State of Kansas should be to encourage innovative educational techniques. Participatory or "hands on" dental education is far superior to being lectured on dental practices on cruise ships or in hotel rooms. By passing House Bill 2218, Kansas can become a leader in the continuing dental education field. Dentists from all over the world can come to Kansas and learn without fear of being prosecuted for violation of the law. The current regulatory scheme stifles the interchange of ideas between dentists of other states and countries. The passage of House Bill 2218 would allow dentists from other states and countries to come Kansas and learn. The passage of House Bill

2218 would allow Kansas dentists to learn by example from dentists of other states. As a consumer of Kansas dental services, I want my dentist to have better educational opportunities than those currently available. As a consumer of dental services, I believe that Kansas dentists that work side by side with dentists from other states and countries will become superior dentists. House Bill 2218 will serve as the framework to allow Kansas dentists to become world leaders in continuing dental education. I urge the committee to pass House Bill 2218.

Madam Chairman and members of the committee, my name is David Hanzlick, I am the Assistant Director of the Kansas Dental Association. I appreciate the opportunity to express the Kansas Dental Association's opposition to House Bill 2218.

Very clearly, the dentists of Kansas understand the importance of continuing education. Kansas dentists must take 30 hours of continuing education each year to renew their license.

Current law also permits the dental association and other like organizations to hold continuing education programs where an out-of-state or foreign dentist may practice dentistry while appearing as a clinician.

The concept contained in House Bill 2218 is very different from current law. House Bill 2218 would permit out-of-state and foreign dentists to perform procedures on patients while participating as students at a continuing education program.

The American Dental Association recently reviewed state statutes and regulations and found no state that permits what H.B. 2218 would allow. Most states, such as California, Florida, Illinois, New York, etc., have provisions very similar to the current Kansas law.

With me today are two dentists who are specialists in Oral and Maxillofacial Surgery. Dr. James Muller of Manhattan and Dr. Thomas Wilson of Salina.

Dr. Muller and then Dr. Wilson will explain their specific concerns with permitting out-of-state and out-of-country dentists to perform procedures on patients while participating as students in continuing education courses in Kansas.

House Public Health & Welfare Committee:

This letter is written to express my concerns regarding the amendment of the Dental Practice Act as proposed by House Bill #2218. The practice of dentistry by licensed dentists from other states and countries within the State of Kansas should be strictly regulated to safeguard patients and to ensure patients are not placed at unnecessary risk or provided substandard care. The teaching of new techniques, via a "hands-on technique", should be limited to approved courses sponsored by major medical and dental teaching centers where the necessary guidelines are in place to ensure patient safety. Hands-on continuing education courses sponsored by major teaching centers are monitored by those institutions to evaluate course content, instructor and student credentials as well as patient outcome. Clinicians involved with teaching center-sponsored courses are credentialed, ensuring their qualifications to teach new techniques as well as qualifications to evaluate the performance of student clinicians. Bill #2218 has no provisions for the credentialing of supervising clinicians and student clinicians, no supervision or evaluation of course content, and no control over teaching methods. There is no peer review to ensure patient safety as well as outcomes within the standard of care.

Major teaching centers have the personnel and facilities for the follow-up care of patients should complications develop as a result of "hands-on training". I do not feel it is appropriate to expect a student in training, learning a new hands-on technique, to be responsible for the follow-up care and treatment of complications resulting from the learned procedure.

Major teaching centers have a peer review process as well as human use committee to ensure that patients receive appropriate care. In today's society, where the media and consumer groups have raised concerns regarding the delivery of quality care to patients and the policing of practitioners by state boards and peer groups, I feel the proposed changes to the Dental Practices Act by House Bill 2218 open the door for inappropriate and substandard "continuing education" being offered in our state. I therefore oppose changes to the Kansas Practice Act as outlined by Bill 2218.

Madam Chairman and members of the Committee:

Thank you for the opportunity to appear before you today on House Bill 2372, concerning suspension or revocation of a medical care facility's license for failure to comply with the provisions of an anatomical gift made in accordance with the Uniform Anatomical Gift Act.

Today, through advanced surgical techniques and new anti-rejection drugs such as cyclosporine, physicians throughout the country are able to transplant a growing number of organs and tissue including corneas, bone marrow, hearts, livers, lungs, pancreases, bones and cartilage, kidneys, even skin. But a 1985 Gallup Poll commissioned by the American Council on Transplantation reported 93 percent of Americans surveyed knew about organ transplantation and, of these, 75% approved of the concept of organ

donation, only 27% indicated that they would more than likely donate their own organs, and only 17% have actually completed donor cards. At any one time, there are an estimated 8,000 to 10,000 people waiting for a donor organ to become available.

There are several other bills that have been introduced related to this issue. House Bill 2490 changes the Uniform Anatomical Gift Act. House Bill 2475 enacts the Uniform Declaratory Judgement. Both bills were heard in the House Judiciary Committee on February 23. HB 2170 and HB 2250 relating to drivers' licenses concerning the anatomical gift statement had hearings on February 11 and February 15 in the House Transportation Committee. None of these House bills have been passed by the committees.

Even though HB 2392 has merit, I don't think you should pass it today. However, our immediate priorities should be to expand and encourage the donation and availability of organs for transplant and to work in a series of partnerships to do this. Therefore, I recommend that this bill and other bills that address this issue should be recommended to the Joint Committee on Health Care Decisions for the 90's. This review should also include a thorough review of all ethical questions related to the issue.

The Kansas Hospital Association appreciates the opportunity to comment regarding the provisions of House Bill 2372. This bill would allow the Department of Health and Environment to suspend or revoke the license of a hospital upon its failure to comply with the provisions of an anatomical gift made in accordance with the Uniform Anatomical Gift Act.

Everyone agrees with the importance of public awareness regarding organ and tissue donations and the need for efficient procedures to make sure that donors' wishes are followed. Indeed, prior to the federal government's involvement in this area, Kansas enacted a "required request" law that mandated the development of policies and procedures to approach individuals and family members about the possibility of organ and tissue donation.

Although the motivation behind House Bill 2372 is commendable, we have several concerns about the way the bill is written. First, we think the penalty is too severe. The bill as written would allow the Department to suspend or revoke a hospital's license for any failure to comply with the provisions of an anatomical gift. This could be true even if there was a situation in which the persons in the hospital acted in good faith. Second, the bill does not take into account that there may be in some instances valid reasons to refuse the provisions of an anatomical gift. In some instances, these reasons may be medical. In others, it may be because the spouse or close family member is adamant about not making the gift. Indeed, current provisions of the uniform anatomical gift law allow certain donees, including hospitals, to refuse a donation.

The House Judiciary Committee is currently considering the provisions of House Bill 2490, which deals with the Uniform Anatomical Gift Act in its entirety. It is unclear whether that committee will take action on the bill this session, but we think it is possible that the bill could be referred to a legislative committee for further study. In that event, it would certainly be appropriate to include in such a study the questions raised by House Bill 2372.

House Bill 2372

Introduction

Thank you for the opportunity to provide testimony today on House Bill 2372. This bill proposes that KDHE would be authorized to deny, suspend, or revoke a medical care facility's license for failure to "comply with the provisions of an anatomical gift made in accordance with the uniform anatomical gift act."

Background

The Uniform Anatomical Gift Act is found at K.S.A. 65-3210 through 65-3218. K.S.A. 65-3218 was added to the act in 1986 and requires all hospitals to develop protocols for the identification of potential donors of body parts. The potential identified donor's next of kin must be asked if the potential donor had authorized the donation of any body parts. If not, the family is to be informed of the option to donate parts of the deceased's body parts in accordance with the Uniform Anatomical Gift Act. Medicare regulations governing hospitals have similar provisions for the identification of potential organ donors and the education of potential donor families (42 CFR 482.12 (c) (5) (i)). Passage of House Bill 2372 would include ambulatory surgical centers by using the term "medical care facility." Both Medicare regulations and the Uniform Anatomical Gift Act refer only to hospitals and do not include ambulatory surgical centers in the required establishment of organ donor protocols.

Currently, KDHE has the authority to deny, suspend, or revoke a medical care facility license only for the following reasons:

- a) substantial failure of the facility to comply with KDHE regulatory requirements established under K.S.A. 65-425 et seq;
- b) failure of a facility to notify the Board of Healing Arts of termination, suspension, or restriction of privileges of a person licensed to practice the healing arts;

- c) failure of a facility to report to the Board of Nursing any mental health technician which has committed an act, or any information which might show that a mental health technician has committed an act, which is grounds for disciplinary action, under K.S.A. 65-4209; or
- d) failure of a facility to maintain a risk management program.

### Issues

It is unknown what the program impact on KDHE might be. Over the past three to five years, the number of organ donations in the U.S. have hit a plateau in spite of enacted "required request" laws as referenced above. Anecdotal evidence of hospitals not always providing families with organ donation options are still prevalent. However, no information is available estimating to what extent families have attempted to make an anatomical gift and been rebuked. It is this scenario which seems to be contemplated in House Bill 2372. The terminology "failure to comply with the provisions of an anatomical gift made in accordance with the uniform anatomical gift act" is confusing when noting that the act itself allows that "the donee may accept or reject the gift" (K.S.A. 65-3215).

Two practical problems for KDHE are presented by House Bill 2372. The first has to do with the unknown scope of the problem attempted to be addressed. Assuming it is a problem that needs to be addressed, the expertise of KDHE to investigate potential complaints related to the issues of K.S.A. 65-3210 through 65-3217 is questionable. Although Medicare certification/licensure generalist surveyors monitor facilities' compliance with the donor protocol requirements, this bill raises very different investigation issues. Determinations would need to be made if a body part donation was actually attempted, that it was done so properly in the context of K.S.A. 65-3210 et seq., and the reasons for refusal. If the problem is large enough to evoke many complaints, the Bureau of Adult and Child Care would need to provide significant surveyor training. BACC staff can not document that any such complaints have ever been received.

As mentioned, KDHE survey staff currently monitor hospital compliance with Medicare regulations which are similar to the requirements of K.S.A. 65-3218. Implementation of House Bill 2372 would seem to be more feasible if KDHE was granted authority to take licensure actions against facilities failing to comply with the required request provisions of K.S.A. 65-3218 rather than the entire Uniform Anatomical Gift Act. Testimony related to the passage of K.S.A. 65-3218 in 1986 identified the lack of any enforcement mechanism.

The second issue rests with the practicality of denying a facility's license for failure to comply with the anatomical gift act. If the problem is extensive, it would seem that providing KDHE with some sort of intermediate sanction for violations would have a more realistic impact.

### Recommendations

KDHE recognizes the importance of education of the general public and the medical community of the importance of organ donor awareness. The importance of hospitals enacting organ donor protocols has also been recognized at the state and national levels. Further, organ and tissue transplantation has made significant strides

in recent years in improving the quality of life of organ recipients. However, House Bill 2372 does appear to have several flaws which lead us to recommend that it not be acted upon until these are addressed.
