The Chairman announced that <u>SB 302</u> would be re-referred through Federal and State and keep alive, and that the hearing on it would be continued at a later date.

He opened the discussion on $\underline{SB\ 336}$ - concerning agricultural corporations; relating to swine production facilities.

Distributed was Alvin Bauman written testimony disagreeing with the analysis made in Professor Flinchbaugh testimony (Attachment 1).

A lengthy discussion followed with members of the committee expressing their viewpoint on SB 336.

Senator Wisdom moved to amended the bill to include dairy production. Seconded by Senator Steffes.

A motion was made by Senator Frahm to adopt the minutes of February 22. Seconded by Senator Sallee. Motion carried.
