<u>Continuation of discussion and action on SB 421</u>—Certain city redevelopment projects, special obligation and tax increment bond financing

A motion was made by Senator Burke and seconded by Senator Vidricksen to recommend SB 421, as amended, favorably for passage. The motion carried on a roll call vote.

Hearing on HB 2507--Kansas economic emergency projects

Representative David Heinemann informed the Committee **HB 2507** creates in the state treasury the Kansas Economic Emergency Projects Fund, and authorizes the State Finance Council to make allocation to, and authorize expenditures by one or more state agencies from, the Fund when the Legislature is not in session. The Finance Council shall be authorized to make such expenditures upon a joint application and certification of the Secretary of Commerce, President of Kansas Inc., and the President of Kansas Technology Enterprise Corporation. \$5 million would be set aside from the Economic Development Initiatives Fund and placed in the Kansas Economic Emergency Projects Fund for economic emergencies which warrant funding for strategic economic intervention by such state agency or agencies to address expenses involved in securing economic benefits or avoiding or remedying economic losses related to 1) a major expansion of an existing Kansas commercial enterprise; 2) the potential location in Kansas of the operations of a major employer; 3) the award of a significant federal or private sector grant which has a state financial matching requirement; 4) the departure from Kansas or the substantial reduction of the operations of a major employer; and 5) the closure of a major federal or state institution or facility. This would be a one time transfer.

Charles Warren, President, Kansas Inc., testified in support of HB 2507. He recommended modifying lines 26 to 32 of Section 1 (b) to "upon recommendation of the Secretary of Commerce and Housing and the President of Kansas Inc, the Governor may certify that an emergency exists...". see Attachment 1.

Kevin Carr, Vice President, Kansas Technology Enterprise Corporation, testified in support of HB 2507, see Attachment 2. He supported all the economic development agencies making recommendations to the Governor and the Finance Council.

House Bill 2507

Senate Commerce Committee March 18, 1993

Madame Chairman, members of the Committee, I would like to speak in support of H.B. 2507 to establish the Kansas Economic Emergency Projects Fund. While I cannot speak to the fiscal capacity of the State to establish this fund, the availability of an emergency fund of this nature would be of great benefit to Kansas and its economic development activities. It would allow a quick response capacity to opportunities and emergencies we lack today.

I would like to suggest that the provision in the bill for application and certification of an economic emergency in lines 26 to 32 of Section 1 (b) be modified to read as follows: □ "upon recommendation of the secretary of commerce and housing and the president of Kansas Inc., the Governor may certify that an economic emergency exists ... " The secretary represents the lead agency in economic development and Kansas Inc. is the policy agency with statutory authority regarding economic emergencies and opportunities, and both are appropriate officers to make such a recommendation. Neither I nor the Secretary would make such certification a involvement of the Governor. The Governor is Co-Chair of Kansas Inc.

With this change, I believe this bill would provide essential resources in a timely fashion for an effective response to the situations outlined in the bill.

TESTIMONY CONCERNING HOUSE BILL 2507
