Confirmation hearings on appointments to Kansas Inc.

John Eddy Moore, Wichita, appeared before the Committee and testified in support of his appointment to Kansas Inc., term expiring June 30, 1996, as the board member representing the primary economic sector of aviation. For the past 10 1/2 years he has been a senior officer and member of the management committee of the Cessna Aircraft Company. He is currently the Senior Vice President of Human Resources. He has also served on the economic development subcommittee of the Special Commission on a Public Agenda; the Economic Development Business Training Task Force; and the Kansas Technology Enterprise Corporation Board of Directors. He is currently Vice Chairman of Kansas Chamber of Commerce and Industry. He has been very active in Children at Risk programs.

In response to Committee questions, Mr. Moore stated he was recommended due to his awareness of the aviation industry and economic development issues in the state of Kansas. He replied he is very comfortable with the public-private format.

Dr. Jay Arnold Anderson, Oberlin, appeared before the Committee and testified in support of his appointment to Kansas Inc., term expiring June 30, 1996, as the board member representing the primary economic sector of agriculture. He practiced as a veterinarian for twenty years. He is a partner in a cattle company and breeds racing greyhounds. He stated he has served on the library board and the board of the area Chamber of Commerce.

In response to Committee questions, Dr. Anderson stated he has been involved in agriculture all of his life, and resides in a rural part of the state. He supports agriculture value added product research and development.
