Specifically, it deletes references to edible bean inspections and says fees shall apply to all crops that may be included in the U.S. Agricultural Marketing Act of 1946. There would be no fiscal impact from the bill.

Committee discussion followed on fees in neighboring states and that there are no standards for popcorn.

## TESTIMONY FOR HOUSE AGRICULTURE COMMITTEE

Senate Bill 729

March 10, 1994

Representative Shore and Members of the Committee:

Senate bill 729 is more of a housecleaning measure.

As you can see, it strikes edible beans in each of the five fee areas and inserts a sentence which says that "the following fees shall be charged for services rendered by the department pursuant to the United States Agriculture Marketing Act of 1946 as amended."

This amendment would give us the flexibility we need to be able to charge fees on a number of crops under the A.M.A., such as edible beans, sunflowers and any other crops which might be put under the A.M.A. in the future.

There would be no fiscal impact from this bill. The fees would remain the same.
