Chairperson Holmes called the meeting to order, referring Committee members to various written materials before them:

- A letter from the City of Hays regarding **HR 5030** (hearing was heard on previous day) (See Attachment #1)
- A report from the Kansas Corporation Commission (See Attachment #2)
- Copy of Congressman Robert's Safe Drinking Water Act Bill, HR 3686 (See Attachment #3)
- Copy of Congressmen Slattery's HR 3392 (See Attachment #4)
- Copy of report from KDHE with comparisons of the above bills. (See Attachment #5)

Representative McClure informed the Committee that she has arranged to have HR 1701 faxed to her. She said since the bill is quite lengthy she will have it available to any members interested in receiving a copy.

Chairperson Holmes reminded the Committee that Thursday of this week they will be working several bills. He asked members to meet with staff if they have amendments for any of the bills that have been heard and have a balloon draft ready at that time.

Hearing on HB 2666:

Karl Mueldener: (See Attachment #6) Mr. Mueldener reported to the Committee that KDHE is requesting this legislation to clarify the intent of KSA 82a-1203 and 82a-1205. He said presently the statute authorizes the Department to adopt regulations for continuing education for licensed water well contractors. The theory of the original legislation was, the more knowledgeable the well driller the better the wells are constructed, thereby providing better protection for public health and the environment. In addition, the original legislation simply required the water well contractor to pursue continuing education rather than the actual onsite drilling supervisor.

Mr. Mueldener said KDHE's proposed legislation required continuing education of the water well contractors and their designated drillers. However, the Attorney General would not approve those regulations due to lack of authorizing legislation regarding designated drillers.

Doug Henkle. (See Attachment #7) Mr. Henkle stated he is a proponent of **HB 2666**. He is a water well contractor and pump installer, and a member of the Legislative Committee of the Kansas Ground Water Association, adding the leadership and general membership of this Association support his views.

He said the Kansas Groundwater Exploration and Protection Act provides for the licensing of water well contractors and states that "in granting of such licenses due regard shall be given to the interest of the state of Kansas in the protection of its underground water resources." His Association supported the 1991 amendment to this Act, wherein it was required that licensed water well

contractors have continuing education; testimony in support of this amendment was presented by his Association at that time.

Mr. Henkle concluded by reporting his Association feels that passage of **HB 2666** would correct an oversight in the original implementation of continuing education requirements.

Hearing on HB 2667:

Charles Jones. (See Attachment #8) Speaking in support of **HB 2667**, Mr. Jones recommended two clarifying revisions to the bill as proposed:

- 1) Page 2, line 7, own facilities ", provided that such abatement projects do not cause, or have the potential to based paint hazard to persons not directly associated with the abatement project."
- 2) Page 7, line 27, asbestos abatement project if the business entity ",non-profit organization"
- 3) Page 7, line 32, (c) If a business entity ",non-profit organization," or state or political or taxing subdivision

Mr. Jones stated the purpose of the bill is to provide KDHE the necessary authority to develop a program that will comply with the lead abatement certification requirements associated with federal Title X Residential Lead-Based Paint Hazard Reduction Act of 1992. He said children are particularly vulnerable to lead poisoning, citing a myriad of negative health repercussions.

The following are some of the major provisions in this proposed legislation, according to Mr. Jones:

- 1. Established a dedicated lead-based paint hazard fee fund that will allow those fees collected from lead-based paint hazard activities to be utilized to fund the lead program.
- 2. Provides administrative authority for developing and implementing regulations to license and certify individuals searching for potential hazards, and to review and approve training courses for them.
- 3. Clarifies authority for KDHE to enter and inspect abatement projects and, when violations are found, to require appropriate action.

It was reported that the first year funding for the lead certification program will be provided through a combination of direct and indirect federal EPA grant funds. The grant monies are scheduled to be awarded by September 30 1994 (application deadline May 1, 1994). Each state that submits a qualifying application will be allocated \$100,000 from the EPA regional office; the EPA funds will be allocated competitively to states, according to a formula designed to reflect each state's relative "lead burden," (the number of housing units with lead-based paint; number of children under age of seven; the fraction of young children in poverty; and the fraction of low-income housing units with lead-based paint. Mr. Jones reports EPA has calculated that Kansas may be eligible for an additional grant of \$50,000 to \$90,000.

Janet Stubbs. (See Attachment #9) Ms. Stubbs spoke of concerns the Kansas Building Industry has with the very broad authority this legislation is giving to the staff of the Secretary of Health and Environment. She said for the Legislature to approve such a measure would give the Department of Health and Environment the authority to promulgate rules and regulations which go far beyond that which is required by Federal regulators and increase the cost of remodeling significantly. Additionally, she maintains intact lead paint has not been shown to be an immediate hazard to children and the removal of same should be a low priority due to limited resources and the fact that it poses little risk.

She stated within the older inner city properties, abatement often will exceed the equity, thereby leading to an ultimate owner-abandonment of property. A question also arises as to who will pay for the abatement.

When urging the Committee not to permit requirements for the removal of intact lead paint, she emphasized the focus should be on in-place management, repair of defective paint, removal of dust, and maintenance of ground cover in high traffic urban areas where children play.

Ms. Stubbs requested permission to supply the Committee with additional information pending from her National office, considering it to be pertinent to this issue.

Representative Powers moved to approve the Committee Minutes for January 24, 25, 26, and 27. Representative Webb seconded the motion. Motion carried.

Upon completion of its business, the meeting adjourned at 4:55 p.m.

The next meeting is scheduled for February 2, 1994.



Dear Representative Holmes:

The City of Hays strongly supports HCR 5030 and respectfully requests the House Energy and Natural Resources Committee take favorable action on the resolution. The City is opposed to unfunded mandates in general and is very concerned about the impact of federal safe drinking water quality standards on the City's budget. For example, the City is faced with a potential \$56,000 in increased expenditures in its Water Fund to comply with the proposed Phase II water testing requirements as mandated by the Safe Drinking Water Act. In order to finance this \$56,000 in potential increased expenditures, the City would either have to raise water rates by 3% or absorb these increased costs which would reduce the amount of money available in the water fund for system maintenance and equipment replacement.

Additionally, some of the tests that are required in the proposed Phase II testing requirements are for substances that have little or know probability of being found in the City of Hays' water supply. The City of Hays strongly believes that any testing requirements should be tied to the potential benefit to public health and safety and therefore supports HCR 5030 which urges Congress to eliminate testing requirements that provide little or no benefit to public health.


The Kansas Corporation Commission submits this report in compliance with requirements of K.S.A. 66-117b.

That statute requires the Commission to monitor and report annually to the legislature any changed rate, joint rate, toll, charge or classification or schedule of charges, or any rule or regulation or practices pertaining to service or rates approved by the Commission in the preceding fiscal year for a public utility or common carrier that had \$10 million or more annual operating revenues in the previous calendar year.


This report covers action taken by the Kansas Corporation Commission for the fiscal year beginning July 1, 1992 through June 30, 1993. As in previous reports, this report includes information on Commission actions regarding utilities with less than \$10 million annual operating revenues. Within each industry, information is given separately for three categories: "Formal" cases of companies with more than \$10 million of revenues, "Formal" cases of companies with less than \$10 million revenues, and all "Informal" matters. "Formal" matters are cases which generally involve an application or petition from the company and a formal Commission order.

ELECTRICITY



In addition to case work, the Commission is engaged in efforts to monitor and respond to developmental changes in the operation and regulation of the electric utility industry. an ever dynamic world as manifest by changes in technology, customer needs, and regulatory structure it is important for the Commission to stay informed so that it can react to and, where necessary, induce change in an appropriate way. recent years regulators and companies alike have accepted the idea that one component of least-cost utility planning requires the company to consider the cost-effectiveness of The KCC has responded conservation or demand-side resources. by constructing a set of Integrated Resource Plan (IRP) rules that (when instituted will) offer both guidance and incentives for designing and implementing cost-effective demand-side programs for Kansas customers. More importantly, the IRP rules provide a basis for the company to identify and describe planning goals and the available means for achieving those The IRP process is intended to give all interested goals. parties in the state, including the general public, special interest groups, legislators, regulators, and other utilities, an opportunity to preview a particular utility's plan for the future. Having this opportunity will likely enhance utility planning and result in improved control over possible rate increases in the future.

The Commission is also engaged in implementing standards contained in the Energy Policy Act of 1992 (EPACT). the provisions of EPACT is a consideration of possible policy changes in the area of electricity transmission and wheeling. This being just one component of a set of possible policy changes intended to induce a transformation of the underlying The aim of any electric industry. structure of the transformation is the introduction of greater competition and the likelihood of lower rates. Furthermore, the Commission is in the process of instituting a mechanism for reviewing (the prudence of) Compliance Plans required by the Federal Clean The Commission is also involved Air Act Amendments of 1992. in several long-term research efforts concerning rate design issues, questions about fuel selection, the possible influence of environmental externalities, the viability of renewable resources and co-generation, resource acquisition methods (particularly, bidding procedures), and IRP review methods and techniques.

The Commission staff continues to digitize state and county utility maps as part of the GIS (Geographical Information System) mapping process. This is part of a long term effort to develop "intelligent" digitized drawings of utility systems and territories. When complete, the maps will cross reference Commission databases and will enable graphic projection on geographical maps prepared by other governmental agencies or private industry. This will improve efficiency in information retrieval and also provide the future capability to transfer requested information over modems or fax machines. In addition digitally updating the maps requires less manpower than the manual techniques used in the past.

NATURAL GAS



The gas industry is in the final stages of a restructuring prompted, in large part, by a series of Federal Energy Regulatory Commission (FERC) orders initiated several years ago and culmination in Order 636. Thus, in addition to case work, the Commission has monitored the restructuring and inquired into its implications for Kansas gas utilities and customers. The Commission is currently engaged in a study numerous questions pertaining to the affects of restructuring the gas industry. In the last year, the Commission devised a means for dealing with the expense associated with rewriting gas contracts that contained, so called, take-or-pay The need to rewrite these contracts stemmed, in provisions. part, from the restructuring. Just as for the electric utilities, and with the same general intent, the Commission has constructed a set of IRP rules for the gas utilities. Similarly, there exist several, as yet unresolved, questions concerning the review of gas IRPs. Many of the long-term research efforts and questions identified vis-a-vis the electric industry also hold for the gas industry. Additional research topics include the possible use of futures contracts (for hedging purposes) by local distribution companies (LDCs), reforming the design of the purchase gas adjustment (PGA) mechanism, and the economic development of alternative uses (i.e., markets) for natural gas.

The Commission staff continues to digitize state and county utility maps as part of the GIS (Geographical Information System) mapping process. This is part of a long term effort t develop "intelligent" digitized drawings of utility systems and territories. When complete, the maps will cross reference Commission databases and will enable graphic projection on geographical maps prepared by other governmental agencies or private industry. This will improve efficiency in information retrieval and also provide the future capability to transfer requested information over modems or fax machines. In addition digitally updating the maps requires less manpower than the manual techniques used in the past.

TELECOMMUNICATIONS



In fiscal year 1993, the Commission initiated an effort to encourage state-wide implementation of enhanced 911 emergency At the Commission's direction, the local telephone companies reduced their facilities rates for 911 to cost. negotiated a stipulation addition, the Commission staff between regulated telephone utilities and the counties providing 911 service. This stipulation provides for improved cooperation between 911 service providers and the telephone companies in ensuring availability of 911 service. The stipulation also contains additional commitment by the 911 service providers to negotiate the appropriate governmental agreements to allow 911 to operate smoothly between counties and various law enforcement and 911 service Further, the Commission staff has obtained and disseminated funding information to the counties. knowledge of funding options, it is hoped the counties would be better able to finance the costs of operating a 911 system.

The Commission has continued to support efforts to link rural areas of Kansas together through interactive video and Members of the Commission improved communication systems. staff participated in a number of user-group meetings, including participation in the Kansas Telemedicine Project sponsored by the Kansas Hospital Association and funded in These user-systems are part by the Wesley Foundation. examining improved and enhanced telecommunications use, including incorporation of interactive video. Interactive video systems are growing in numbers and capability and are allowing a variety of educational, medical and private information to flow among rural and more urban Kansas continues to be in the forefront nationcommunities. wide in the advanced use of telecommunications.

Revised access charges were put into place as scheduled with the resultant cost savings being flowed-through to long distance customers as called for in the stipulation and order. AT&T long distance rates were decreased \$720,000 annually as a result of the access charge plan. As in previous years, most other long distance companies, while not under the same obligation as AT&T under terms in the access stipulation, also reduced rates accordingly to match those of AT&T. Commission staff has begun work on designing the next access plan, since the existing plan will expire at the end of calendar year 1994.

The modernization of Southwestern Bell's communications network called for in the alternative regulatory plan called "TeleKansas" continued, as in previous years, slightly ahead of schedule. Southwestern Bell exercised its ability to request streamlined regulatory approval on certain services and received approval to place numerous services into the "Flexibly Priced" service category.

Local telephone companies came to the aid of flood victims during the summer of calendar year 1993. Local telephone company employees took extraordinary efforts to keep central offices functioning and keep communications intact in flood areas. The Commission maintained in contact with the companies and expedited approval of flood relief measures where necessary.

The Dual Party Relay System continued to flourish. The volumes of calls handled by the relay center operators, providing a link between the speech and hearing impaired community and existing telecommunications customers, continued to increase. Commission approval of minor adjustments in the system's operations had been requested by the board which oversees the project at the close of fiscal year 1992. Those adjustments were approved by the Commission in 1993.







COMMON CARRIERS

Only one common carrier railroad reported Kansas intrastate operating revenue in excess of \$10,000,000 for calendar year 1992. Please note that common carrier railroads, motor carriers and pipelines report on a calendar year basis rather than a fiscal year basis. The Atchison, Topeka and Santa Fe Railway Company reported revenue of \$22,412,000 for 1992. This common carrier railroad did not file any applications for rate increases with this Commission during calendar year 1993, to date. The Atchison, Topeka and Santa Fe Railway Company has not filed any applications to discontinue agency service in 1993.

One common motor carrier reported Kansas intrastate operating revenue in excess of \$10,000,000 for calendar year 1992. That common motor carrier was United Parcel Service, MCID 107100, and it reported Kansas intrastate operating revenue of \$18,424,251 for calendar year 1992. This carrier was granted an increase, effective February 15, 1993, of 4.5% on Kansas intrastate traffic.

Each State that grants a variance shall promptly notify the Administrator of the granting of such variance. The Kansas Department of Health and Environment House Bill 2666

KDHE requests this legislation to clarify the intent of KSA 82a-1203 and 82a-1205 pertaining to the licensure of water well contractors and their designated water well drillers. Present statute authorizes KDHE to adopt regulations for continuing education for licensed water well contractors. Proposed amendments include designated driller as being required to complete continuing education. The theory of the original legislation was the more knowledgeable the well driller, the better wells are constructed and public health and the environment are The original legislation simply required the water well contractor to pursue continuing education rather than the actual on-site drilling supervisor, commonly referred to as the driller.

KDHE has adopted regulations requiring continuing education for the contractor. proposed regulations required continuing education of the water well contractors and their designated drillers, but the attorney general would not approve those regulations due to lack of authorizing legislation regarding designated drillers. During the regulatory hearing process, those making comments were supportive of the requirement being placed on the driller as well as the water well contractor.

TESTIMONY BEFORE the HONORABLE CHAIRMAN AND MEMBERS of the HOUSE ENERGY and NATURAL RESOURCES COMMITTEE HOUSE BILL 2666

Chairman Holmes and Members of the Committee, I appreciate the opportunity to testify before you this afternoon as a proponent of House Bill 2666. My name is Doug Henkle and I am a water well contractor and pump installer from Garden City and a member of the Legislative Committee of the Kansas Ground Water Association. The views I will present this afternoon have the support of the leadership and general membership of that organization.

The Kansas Groundwater Exploration and Protection Act provides for the licensing of water well contractors and states that "in granting of such licenses due regard shall be given to the interest of the state of Kansas in the protection of its underground water resources". The Kansas legislature and this committee has done much over the years to ensure that the quality of our state's precious ground water is protected. In 1991, in order to further assure the quality of Kansas groundwater, the Kansas legislature amended the Groundwater Exploration and Protection Act to require continuing education for the <u>licensed</u> water well contractor in order that he would be familiar with current Kansas water law and well construction standards. Our association, then known as the Kansas Water Well Association, supported that amendment and provided testimony to this committee stating as much.

When the Kansas Department of Health and Environment proposed rules and regulations to implement the amendment to the Act they determined that often times, as is the case in my own firm, the licensed water well contractor who is now required to have continuing education, is not always the driller who is on the job, constructing the well. Rather, the driller who is in the field daily may be an employee of the licensed contractor working under the contractor's direction and not required to have any continuing education. In light of that fact, House Bill 2666 has been proposed.

The Kansas Ground Water Association supports House Bill 2656 and we feel that your passage of the pill would correct an oversight in the original implementation of continuing education requirements for water well contractors in Kansas.

House Bill 2667

The Kansas Department of Health and Environment is pleased to provide testimony in support of House Bill 2667 and to recommend two clarifying revisions to the bill as proposed. The purpose of this bill is to provide the agency the necessary authorities to develop a program that will comply with the lead abatement certification requirements associated with the federal Title X Residential Lead-Based Paint Hazard Reduction Act of 1992. This federal law was enacted to prevent and eliminate lead poisoning among children. Lead is a highly toxic metal, producing a broad range of adverse health effects, including nervous and reproductive system disorders, delays in neurological and physical development, cognitive and behavioral changes, and hypertension. Children are especially vulnerable to this problem, since most lead poisoned children do not appear to be sick. Childhood lead poisoning resulting from environmental exposures is estimated by the Centers for Disease Control (CDC) to affect 17 % of children from ages six months to six years. Preliminary results from blood lead screenings conducted in the State of Kansas indicate that these estimates are representative of the risk in Kansas.

There are many environmental sources of lead, including soil and dust contaminated by leaded gasoline, drinking water contaminated by lead plumbing, and lead-containing glazes on dishware, but the most preventable source of high-intensity exposures, is deteriorating lead-based paint. Such paint was widely used in residential and institutional structures before being restricted in 1978. The federal legislation requires the U.S. Environmental Protection Agency (EPA) and the U.S. Department of Housing and Urban Development (HUD) to develop comprehensive rules and regulations governing the abatement of lead-based paint in properties not managed by HUD. EPA is responsible for the development of a model accreditation program whereby individuals involved with lead-based paint inspection and abatement work must be trained and accredited. The objective of the lead certification program is to assure that lead abatement contractors use proper procedures, so as to prevent widespread lead contamination from abatement operations.

The federal legislation also provides grant funds, administered through HUD, that can be used to abate private residences that have been identified at high risk of child lead exposure and that meet HUD income criteria requirements. Congress authorized \$125,000,000 for federal fiscal year 1993 and \$250,000,000 for federal fiscal year 1994 to implement the federal residential lead abatement program. Each state may be eligible for up to \$6,000,000 for qualifying projects. However, to be eligible for these funds, states must develop and implement a lead abatement certification program. This proposed legislation will provide KDHE with the necessary statutory authorities to implement a certification program that meets the criteria required to make Kansas eligible for U.S. HUD funds.

Currently, the Secretary of the Department of Health and Environment has authority under K.S.A. 65-5301 et.seq. the Asbestos Control Act, to license and certify individuals who engage in the removal and encapsulation of friable asbestos-containing materials. The lead certification requirements proposed by EPA, for individuals involved in lead-hazard detection and lead-hazard reduction activities are very similar to those of the asbestos certification program. Such requirements will include attending approved certification training, passing a written examination, and payment of any required certification fees. Building upon the success of the asbestos certification program, the agency has recommended revising existing statutes, in lieu of introducing new legislation.

The proposed legislation contains the following major provisions:

- 1. Establishes a dedicated lead-based paint hazard fee fund that will allow those fees collected from lead-based paint hazard activities to be utilized to fund the lead program.
- Provides administrative authority for developing and implementing regulations to license and certify individuals who detect or abate leadbased paint hazards.
- 3. Provides authorities for developing and implementing regulations that would allow KDHE to review and approve training courses for individuals who would be responsible for the detection or abatement of lead-based paint hazards.
- 4. Clarifies authorities for KDHE to enter and inspect abatement projects and when violations are found, to require that appropriate corrective action be taken.

The first year funding for the lead certification program will be provided through a combination of direct and indirect federal EPA grant funds. EPA has advised that approximately ten million dollars in grant monies will be available nationwide to fund the development and implementation of state lead certification programs. The grant monies will be awarded by September 30, 1994, with the application deadline of May 1, 1994. EPA reports that the monies will be divided into two parts. Each state that submits a qualifying application will receive a minimum amount of \$100,000 from the EPA regional office. The second pool of EPA funds will be allocated competitively to states according to a formula designed to reflect each state's relative "lead burden". EPA defines lead burden as meaning: 1) the number of housing units

with lead-based paint; 2) the number of children under the age of seven; 3) the fraction of young children in poverty; and 4) the fraction of low-income housing units with lead-based paint. EPA has calculated that Kansas, utilizing 1990 census data, may be eligible for an additional grant of \$50,000 to \$90,000.

It is anticipated that the lead certification program will attract interest by at least 50 firms in licensing under the program, not including commercial painting, and renovation firms that may be involved in this work.

Attachments 1 and 2 to this testimony contain agency recommendations for two revisions to the bill. The first clarifies the types of abatement projects that are exempt from the licensing and certification requirements to assure that the general public is fully protected from any lead that might be released from this type of work. The second revision includes authority to exempt non-profit organizations from the licensing and certification requirements upon approval by KDHE provided that public health protection requirements are met.

(b) Except as provided in this subsection, the provisions of this act do not apply to a business entity which uses its own employees in removing or eneapsulating asbestes to perform an abatement project for the purpose of renovating, maintaining or repairing its own facilities. A business entity which is exempted from applicability of the provisions of this act and which assigns an employee to remove or eneapsulate asbestes shall provide netification to the secretary in the manner prescribed by the secretary of their intent to conduct such activities and shall provide training on the health and safety aspects of the removal or eneapsulation including the federal and state standards applicable to asbestes projects. (a) Prescribe fees for the issuance and renewal of certificates and licenses. The fees shall be based upon the amount of revenue determined by the secretary to be required for proper administration of the provisions of this act;

(b) conduct at least one on-site inspection annually of procedures being utilized by a licensee for removing and eneapsulating asbestes to perform abatement project activity during an actual asbestes abatement project;

(c) inspect and approve asbestos abatement project waste disposal sites; and

(d) adopt rules and regulations necessary for the administration of this act including, but not limited to, requirements, procedures and standards relating to asbestos abatement projects as are necessary to protect the public health and safety.

Sec. 4. K.S.A. 65-5304 is hereby amended to read as follows: 65-5304. In order to qualify for a license, a business entity shall:

(a) Ensure that each employee or agent of the business entity who will come into contact with asbestos or who will engage in an asbestos abatement project is certified;

(b) demonstrate to the satisfaction of the secretary that the business entity is capable of complying with all applicable requirements, procedures, standards of the United States environmental protection agency and, the United States occupational safety and health administration and the secretary;

(c) have access to at least one approved asbestos abatement pro-

, provided that such abatement projects do not cause, or have the potential to cause, a lead-based paint hazard to persons not directly associated with the abatement project.

- (c) Before any license or certificate is denied, suspended or revoked, the secretary shall conduct a hearing thereon in accordance with the provisions of the Kansas administrative procedure act.
- (d) Any individual person or business entity aggrieved by a decision or order of the secretary may appeal the order or decision in accordance with the provisions of the act for judicial review and civil enforcement of agency actions.
- (e) (1) If the secretary finds that the public health or safety is endangered by the continuation of an asbestos abatement project, the secretary may temporarily suspend, without notice or hearing in accordance with the emergency adjudication procedures of the provisions of the Kansas administrative procedure act, the license of the business entity or the certificate of any person engaging in such asbestos abatement project.
- (2) In no case shall a temporary suspension of a license or certificate under this section be in effect for a period of time in excess of 90 days. At the end of such period of time, the license or certificate shall be reinstated unless the secretary has suspended or revoked the license or certificate, after notice and hearing, or the license has expired as otherwise provided under this act.
- Sec. 11. K.S.A. 65-5311 is hereby amended to read as follows: 65-5311. (a) In an emergency that results from a sudden, unexpected event that is not a planned renovation or demolition, the secretary may waive the requirement for a license.
- (b) The secretary may approve, on a case-by-case basis, an alternative to a required public health protection procedure for an asbestos abatement project if the business entity or state or political or taxing subdivision of the state submits a written description of the alternative procedure to the secretary and demonstrates to the satisfaction of the secretary that the proposed alternative procedure provides equivalent protection.
- (c) If a business entity or state or political or taxing subdivision of the state is not primarily engaged in the removal or encapsulation of asbestes abatement projects, the secretary may waive the requirement for a license or employee certification if public health protection requirements are met or an alternative procedure is approved under subsection (b).

TESTIMONY for HOUSE ENERGY & NATURAL RESOURCES COMMITTEE

Mr. Chairman and Members of the Committee:

My name is Janet Stubbs appearing today on behalf of the Kansas Building Industry today to express our concern with the very broad authority this legislation is giving to the staff of the Secretary of Health & Environment under HB 2667. For the Legislature to approve such a measure would give the Department of Health & Environment the authority to promulgate rules and regulations which go far beyond that which is required by Federal regulators and increase the cost of remodeling significantly, thus preventing the ability of some owners to do the project.

HUD estimates that the cost of covering all lead paint in the 57 million private dwellings with lead paint at \$363 billion and the cost of removing it at \$499 billion. The average per unit cost of abatement is \$5,453 for encapsulation and \$7,700 for removal. In 4.7 and 9.2 percent of units, respectively, the cost exceeds \$25,000.

Interior and exterior lead dust from deteriorated lead paint and past fallout from leaded gasoline emissions, is the most significant source of lead exposure in children. Intact lead paint has not been shown to be an immediate hazard to children. However, when the lead paint is chipping, peeling, or flaking, or becomes dust through sawing, dry sanding, and dry scraping, the hazard is immediate. Public and private resources should be directed to in-place management efforts. Removal of intact paint should be a low priority due to limited resources and the fact that it poses little risk.

In the areas of greatest need, older inner city properties, the cost to abate will often exceed the owner's equity and sometimes even the entire value of the property. Abatement requirements could lead to abandonment of property.

Questions arise as to who will pay for the abatement? Can Federal, State and Local government afford these costs? Government cannot afford the billions required for public housing and FHA and VA properties upon which foreclosure has taken place, let alone to potential sum of one-half trillion for the private sector.

How far does the State of Kansas intend to go with this mandate? We urge you not to permit requirements for the removal of intact lead paint. Instead, the focus should be on in-place management, repair of defective paint, removal of dust, and maintenance of ground cover in high traffic urban areas where children play.

These are very brief remarks due to the material being forwarded by our National office not arriving. I would request permission to supply the committee with additional information received which may be deemed pertinent.
